Subject: Three-Year Term Contract with Two Years of Renewal Options for

Uninterruptible Power Supply Preventative System Maintenance and Related

Services, Equipment and Parts for Various City Departments (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Mesa Fire and Medical Department, Parks, Recreation and Community Facilities Department, Information Technology Department (PRCF), and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposal from Titan Power, Inc., at \$207,600 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

This contract will provide Uninterruptible Power Supply (UPS) preventative system maintenance, related services, equipment and parts per the scope of work and specifications. Mesa Fire and Medical, Information Technology – Communications, and PRCF - Facility Maintenance have a need for UPS maintenance and repair services at various City locations.

The City received six proposals of which, one respondent was deemed as non-responsive for not submitting the revised proposal questionnaire and price sheet as required. The committee then evaluated and scored the proposals based on the evaluation criteria as stated in the solicitation and references were scored based on proposers providing all requested information, which included services performed. Communications Power Solutions, Inc. and NGH Power Systems, Inc. fell outside of the competitive range and were deemed not reasonably susceptible for award.

The evaluation committee completed scoring responses and determined that Titan Power, Inc., submitted the most advantageous offer, and unanimously recommends awarding the contract to the highest scored proposal, Titan Power, Inc.
