Subject:	Three-Year Term Contract with Two Years of Renewal Options for Aftermarket Parts for Automotive and Light Duty Trucks for the Fleet Services Department) <b>(Citywide)</b>

#### Recommendation

Council is requested to approve the award as recommended.

A committee representing the Fleet Services Departments and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored respondents of each Group (1 to 24): Parts Authority Arizona, LLC (a Mesa business); FleetPride, Inc. (a Mesa business); Parts Mart Inc.; and RWC International dba RWC Group; at \$360,250 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

#### **Background / Discussion**

This contract will provide several vendors for various equipment manufacturer's aftermarket parts that meet or exceed the original manufacturer's specifications in quality, size, fit and operation (premium) to support Mesa's fleet of light duty vehicles.

The City maintains a fleet of over 1,700 automobiles and light duty trucks. It is a diversified fleet of passenger cars, patrol sedans, pickups, utility vans plus an assortment of small engine equipment. To meet the service requirements of Fleet Service's operations, the vendors will be required to provide quality replacement, add on parts and timely delivery.

In addition, the contract requires the vendor to have a parts outlet facility within the Mesa/Phoenix metropolitan area and maintain an inventory of parts that are sufficient to meet the needs of the City. In order to maintain a reliable supply of repair parts, the City reserves the right to make multiple awards.

Award is being recommended to the four, highest scored respondents of each Group, 1 to 24, that meet all qualifications and specifications: Parts Authority Arizona, LLC, FleetPride, Inc., Parts Mart Inc., and RWC Group. The evaluation unanimously agreed on the recommendation.
