A RESOLUTION OF THE COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, APPROVING AN INCREASE IN THE MAXIMUM DOLLAR AMOUNT FOR INDIVIDUAL JOB ORDERS UNDER JOB ORDER MASTER CONTRACTS JOC-G15, JOC-L15, JOC-U15, JOC-W17, JOC-NG18, AND JOC-T18 FROM ONE MILLION DOLLARS TO ONE MILLION FIVE HUNDRED THOUSAND DOLLARS, AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNATED REPRESENTATIVE, TO APPROVE FUTURE JOB ORDERS UNDER THESE JOB ORDER MASTER CONTRACTS CONSISTENT WITH THIS RESOLUTION.

WHEREAS, on March 14, 2016, the City Council approved the selection of CORE Construction, Inc. and SDB Contracting Services for Job Order Master Contracts for General Construction Services (JOC-G15) with a limit of One Million Dollars per job order; and

WHERAS, on March 14, 2016 the City Council approved the selection of Valley Rain Construction Corporation and Earthscapes, Inc. for Job Order Master Contracts for Landscape Construction Services (JOC-L15) with a limit of One Million Dollars per job order; and

WHEREAS, on March 14, 2016 the City Council approved the selection of Talis Construction Corporation and B&F Contracting, Inc. for Job Order Master Contracts for Utility Construction Services (JOC-U15) with a limit of One Million Dollars per job order; and

WHEREAS, on May 22, 2017 the City Council approved the selection of Garney Companies, Inc. and PCL Construction, Inc. for Job Order Master Contracts for Water and Wastewater Construction Services (JOC-W17) with a limit of One Million Dollars per job order; and

WHEREAS, on January 7, 2019 the City Council approved the selection of RP Companies, Inc. for a Job Order Master Contract for Gas Line Construction Services (JOC-NG18) with a limit of One Million Dollars per job order; and

WHEREAS, on January 7, 2019 the City Council approved the selection of Talis Construction Corporation and Nesbitt Contracting Company, Inc. for Job Order Master Contracts for Transportation Construction Services (JOC-T18) with a limit of One Million Dollars per job order; and

WHEREAS, Arizona law allows an increase or decrease in the maximum dollar amount of an individual job order where approved by the municipal agency; and

WHEREAS, an increase in the maximum dollar amount for individual job orders from One Million Dollars to One Million Five Hundred Thousand Dollars will account for industry-wide increase in construction costs and allow for the procurement of "on-call" construction services of the size and scope originally contemplated under the City's existing Job Order Master Contracts.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MESA, COUNTY OF MARICOPA, ARIZONA, AS FOLLOWS:

<u>Section 1:</u> That the maximum dollar amount for individual job orders under Job Order Master Contracts JOC-G15, JOC-L15, JOC-U15, JOC-W17, JOC-NG18, and JOC-T18 is hereby increased from One Million Dollars to One Million Five Hundred Thousand Dollars;

<u>Section 2:</u> The City Manager or his designee is authorized to prepare, sign and submit any and all documents necessary to implement this Resolution without further authorization from the City Council.
