PHA Plan Update

Purpose and Recommendation

The purpose of this report is for the Mesa Housing Services Governing Board ("Board") to review and approve the update of the Fiscal Year 2019/2020 PHA Annual Plan. Staff is recommending that the Board adopt a resolution regarding the approval to the Annual Plan.

Background

The City of Mesa Housing and Community Development Division prepared the Five-Year PHA Plan in April 2015 that was provided to the U.S. Department of Housing and Urban Development ("HUD"). The Five-Year PHA Plan provides information on the City of Mesa PHA and its goals and objectives for Fiscal Years 2015-2019. The PHA's Annual Plan, which is submitted each year to HUD, provide an update to the Five-Year Plan goals and objectives for assisting families in Mesa with rental subsidy under the Section 8 Housing Choice Voucher Program.

Discussion

The Fiscal Year 2019/2020 Annual Plan is attached for review and approval by the Board. The Annual Plan is consistent with HUD's overall mission for housing authorities "to promote adequate and affordable housing, economic opportunity, and a suitable living environment free from discrimination". City staff obtained input from the Resident Advisory Board on the Fiscal Year 2019/2020 Annual Plan on February 14, 2019. The Annual Plan went out to public comment through a Public Notice that ended April 3, 2019. No public comments were received.
