Subject: Purchase of a Compressor (Addition) for the Police Department (Sole

Source) (Citywide)

### Recommendation

Council is requested to approve the award as recommended.

The Police Department and Purchasing recommend awarding the contract to the sole source vendor, Atlas Copco at \$77,138.72, based on estimated requirements.

## **Background / Discussion**

The Police Department purchased the current system less than a year ago. Engineering performed a thorough evaluation and concluded that the ZT37 Two Stage, Oil Free, Air Cooled Compressor and accessories met the laboratory's needs. The compressor runs full time. Regular maintenance and routine part replacements are expected for equipment upkeep and consumable wear and tear. These events lead to temporary shut downs. A full backup system is required for the Forensic Services Division to remain operational.

This purchase will provide a secondary system that will help maintain operational and performance maintenance on one system without shutting the process down completely. It takes a week or more to receive parts and repair. An identical secondary system will use the same parts which can be purchased and kept on hand for immediate repairs for both compressors. This will also eliminate the need to coordinate with two separate vendors when programming the rotational workload. Facilities Maintenance and Forensic Services staff are familiar with the current ZT37 compressor system which facilitates troubleshooting.

Atlas Copco operates both direct factory representation and distribution in Arizona. This equipment is not part of a distributors contract making Atlas Copco the sole source in Arizona for this product.
