Subject: Three-Year Term Contract with Two Years of Renewal Options for
Playground and Parks Equipment for the Parks, Recreation and Community
Facilities **(Citywide)**

Recommendation

Council is requested to approve the award as recommended.

The Parks, Recreation and Community Facilities Department (PRCF) and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidders: Dave Bang Associates, Inc.; PlaySpace Designs, Inc.; Miracle Recreation Equipment Company; Playcore Wisconsin, Inc. dba GameTime; and Arizona Recreation Design, Inc.; at \$150,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

PRCF maintains 63 parks sites that consists of playground pieces, trash receptacles, bleachers, tables, players' benches, basketball hoops, grills, etc.

This contract will provide playground and park equipment (Playworld Systems, Wabash Valley, Kompan, Lapsett, Landscape Structures, Miracle, Xccent, GameTime, Dynamo, Little Tikes, Exerplay and Greenfields Outdoor Fitness) on an as-needed basis. The vendors will also install, maintain and repair the equipment to keep the City's parks sites safe and functional.
