Subject: Purchase of Nine Pickup Trucks (Seven Replacements and Two Additions)

for Various City Departments as requested by the Fleet Services Department (Funded by the Vehicle Replacement, Capital - Enterprise Fund, Capital - General Fund and the Utility Replacement Extension and Renewal Fund)

(Citywide)

Recommendation

Council is requested to approve the purchase as recommended.

The Fleet Services, Water Resources, Energy Resources, and Parks, Recreation and Community Facilities Departments and Purchasing recommend authorizing the purchase from the existing contract with Larry H Miller Ford Mesa (formerly Berge Ford) (a Mesa business) at \$320,581.97.

Background / Discussion

This purchase is for nine, 2019 F150's to support the Fleet Services, Water Resources, Energy Resources, and Parks, Recreation and Community Facilities Departments.

Six of the vehicles that are being replaced for Fleet Services have met established criteria and will be either traded, auctioned, sold, or deployed to special uses as part of the City's ongoing vehicle replacement program – the six, new replacement pickup trucks are for Fleet Services' motor pool. One vehicle is being replaced for Gas Utility to replace a vehicle that was damaged beyond repair.

One addition is for Water Resources, to support their daily operations. The other addition is for Park Rangers staff which increased from five to seven Rangers in 2017. The new F150 truck will be used to patrol parks, basins, trails and other PRCF properties, to conduct general public relations, public education, and enforcement of City ordinances. This vehicle addition will bring the fleet up to six vehicles for the current seven Park Rangers.

All nine vehicles are additional purchases from a contract Council previously awarded that allows for additional purchases.
