Subject:	Three-Year Term Contract with Two Years of Renewal Options for Emergency Medical Supplies and Pharmaceuticals for the Mesa Fire and Medical Department (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Mesa Fire and Medical Department (MFMD) and Purchasing recommend awarding the contract to the highest scored proposal from Bound Tree Medical, LLC, at \$535,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

This contract provides medical supplies per specifications for all emergency medical operations. MFMD's Emergency Medical Services and the Resources Divisions purchase and stock emergency medical supplies including pharmaceuticals for distribution to its fire stations.

These emergency medical supplies include pharmaceuticals; airway and oxygen delivery items; diagnostic supplies; first aid supplies; infection control supplies; instruments; IV supplies; monitoring and defibrillation equipment; patient handling equipment; splinting and immobilization supplies; suction and related equipment; wound care and related supplies; and miscellaneous supplies. Bound Tree Medical, LLC will provide the City with eight, UCaplt Dispensing Systems and related software for the initial contract term. The dispensing machines will allow sworn fire personnel to restock apparatus with pharmaceuticals at select fire stations rather than driving and replenishing at the hospital. The machines will reduce apparatus from being out of service and will create security measures for the controlled substances and medications.

The City received nine proposals, seven of which met the minimum qualifications. The evaluation committee completed the scoring based on the evaluation criteria in the solicitation and award is being recommended to the highest scored respondent, Bound Tree Medical, LLC. The evaluation committee unanimously agreed on the recommendation.
