Subject: Three-Year Term Contract with Two Years of Renewal Options for Safety

Shoes for Various City Departments as requested by the Human Resources

Department (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Human Resources Department – Safety Services and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the qualified respondents: JRs Shoes and Boots, LLC; Colistro Family LLC, dba Red Wing Shoe Store – East Valley; and GP Distributing, Inc., dba Shoppers Supply; at \$150,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

The City is responsible for ensuring employees who are, or expected to be, exposed to certain workplace hazards are provided proper personal protective equipment (PPE) in order to avoid on the job injury and/or illness. There are more than 1,000 employees in over 80 job titles that require PPE for foot protection.

Safety Services has evaluated the offerings of the recommended vendors and determined they meet the objective of the safety shoe program in services, quality products that meet OSHA requirements, and reasonable pricing. Having multiple vendors is important so that employees are given ample options while ensuring the safety shoe meets the safety requirements for the work they perform.

The City received four proposals, of which, all met the minimum qualifications. The evaluation committee then evaluated the responses based on the scoring criteria as stated in the solicitation. Each vendor met all the specifications in the solicitation. The evaluation was conducted by and points were awarded by consensus by the evaluation committee, which unanimously agreed on the recommendation.
