Overview: The purpose of this Citizen Participation Report is to provide an overview of what occurred from the initial submittal of the formal applications with informing and getting feedback from citizens, property owners, neighbor/homeowners associations, etc. within the vicinity of the property proposed for a planned mixed-use/residential development. This site is generally located at the 6000 through 6400 blocks of the south Crismon Road alignment (east side), the 10000 to 10600 blocks of East Williams Field Road (south side) and the 6000 through 6400 blocks of South 222nd Street (west side), which we are requesting approval of annexation and rezoning cases for a mixed-use/residential development called the Avalon Crossing Community Plan on approximately 182 gross acres of vacant land. We believe the following endeavors have adequately ensured that those affected by or interested in these applications have been informed as well as had an opportunity to learn about, ask questions, and provide comments regarding this proposal for a mixed-use/residential development.

Notification of Neighborhood Meeting Letter:** A Notice of Applications Filed/Neighborhood Meeting letter with exhibits were mailed on March 13, 2019, to city registered neighborhoods and homeowners associations within one-mile of the property as determined by the City of Mesa Neighborhood Outreach Office and property owners within one-thousand feet of the property as determined by the Maricopa County Assessor. Dear Property Owner/Neighborhood Association/Interested Party:

Please accept this letter as an invitation to attend a neighborhood meeting, which is being held to discuss our client's recent submittal applications to the City of Mesa for Annexation and Rezone to allow for a mixed-use/residential development on approximately 182 gross acres (the "Property"). (See the attached: *Location Aerial Map*.) Most of the Property is currently located within unincorporated Maricopa County. With that said, our requests are for: annexing approximately 162 acres into the City of Mesa and rezoning the entire Property to a Planned Community Development ("PCD") zoning designation. The goals of the proposed PCD are to provide for a community plan and document that is thoughtfully designed with the appropriate allocations/integration of land uses, market ready for development, and reflective of the City's endeavors for a more sustainable and livable approach to development within the Gateway Area of the City of Mesa. (See the attached: *Conceptual Parcel Allocation/Parks & Open Space Plan*.) The proposed PCD plan/document establishes the legal regulatory framework and design standards necessary to facilitate the community envisioned.

A brief overview of the project: the proposal is being planned as a New Traditional Community that draws influence from modern smart growth principles as well as the timeless qualities of historic American neighborhoods. The community will be defined by four distinctive planning principles, which act as the structuring elements of the master plan. These include classic, formal tree-lined streets that double as important public places; compact, walkable neighborhoods united by interconnected paseos and sidewalks; purposeful architecture comprised of simple building forms and durable materials; and integrated parks and amenities designed to contribute to the overall structure and social identity of the community. Residential living opportunities will be comprised of single-residence and multi-residence neighborhoods. Specifically, single-residence homes will be more compact than historical auto-oriented suburban development, with residences designed to engage the street and foster a socially interactive community. In addition, the plan will offer locally oriented retail services during the early phases of development that will be designed with strong connections to the residential neighborhoods. We believe the result, once completed, of the proposed development will be an enhancement to the overall area as

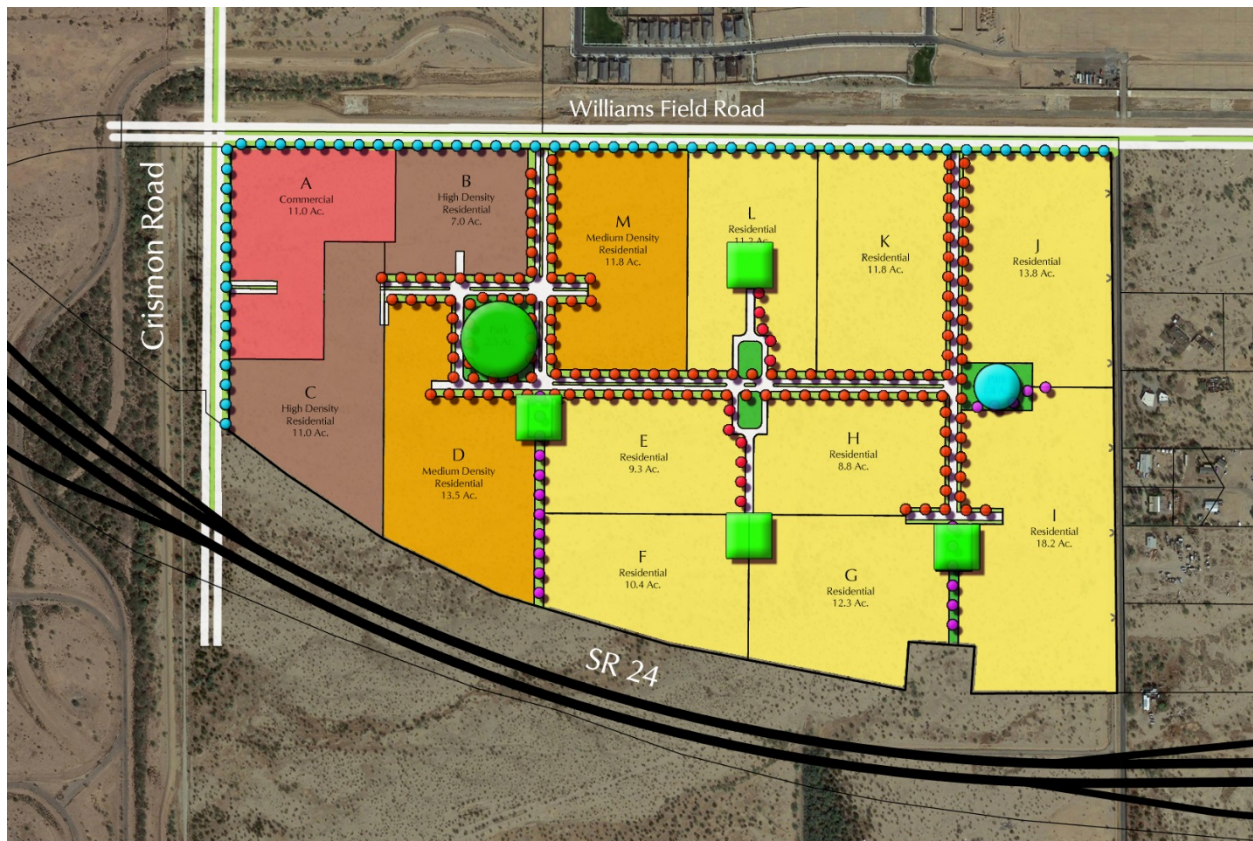

Cassandra Ayres and Dennis Newcombe, of Beus Gilbert PLLC, conducted the neighborhood on behalf of the applicant, Pacific Proving, LLC. Seven people signed the sign-in sheets, although approximately 9 people attended the neighborhood meeting. The general comments and questions were as follows:

1. What is the alignment of the SR-24 in relation to the project?

Response: The SR-24 alignment is currently south of the project.

2. Will Williams Field Road continue past the SR-24?

Response: As currently planned, Williams Field Road will have 6 lanes (3 in each direction) east of Crismon Road, and will have an interchange with the SR-24. Williams Field Road will “go under” the SR-24 west of Crismon Road and the number of lanes will be reduced to 4 (2 in each direction).

3. Are apartments contemplated as part of the project and where are they located?

Response: There are two high density residential parcels shown on the Conceptual Parcel Allocation Plan (Parcels B and C). Although apartments are likely in those two Parcels, the residential product could also be condominiums. The ultimate residential product is unknown at this time, but it is intended to be high density, which will buffer the medium density and low density residential product from the commercial development immediately adjacent to Williams Field and Crismon Roads.

4. Where is the commercial and what kinds of business will be there?

Response: The commercial area is located on the Conceptual Parcel Allocation Plan at the immediate southeast corner of Williams Field Road and Crismon Road. The intent of the plan is to allow a variety of goods and services, such as grocery and drug stores, restaurants, medical and professional offices, gas stations, etc., that will meet the needs of the project's residents and encourage pedestrian connectivity and access. No users have been identified at present.

5. Where are the new SRP power lines going to be located?

Response: We're not certain where "smaller" power lines are going to be located, but the new "large" SRP lines that are being built to ensure consistent supply and redundancy to the technology corridor and the new data centers are generally supposed to run along the southern edge of the SR-24 alignment.

6. Will the property owner put a fence up around the property?

Response: It is unlikely that the owner will fence the property owner due to the expense involved in fencing nearly 200 acres, but we will inquire with the property owner.

7. Will the developer be required to build what is in this PCD if it is approved?

Response: If this PCD is approved, the developer will be required to follow the development standards within the development parcels. The developer could build less density than what is approved, but if the developer (or any developer) wants to build greater density, they will have to go back through the public hearing process to amend the PCD.

8. What is the timing on development?

Response: Timing depends on the market, but if the market remains positive, we anticipate starting Phase 1 (e.g., the commercial and high density residential) of the project in the next 2-3 years, and complete Phase 1 in approximately 5 years.

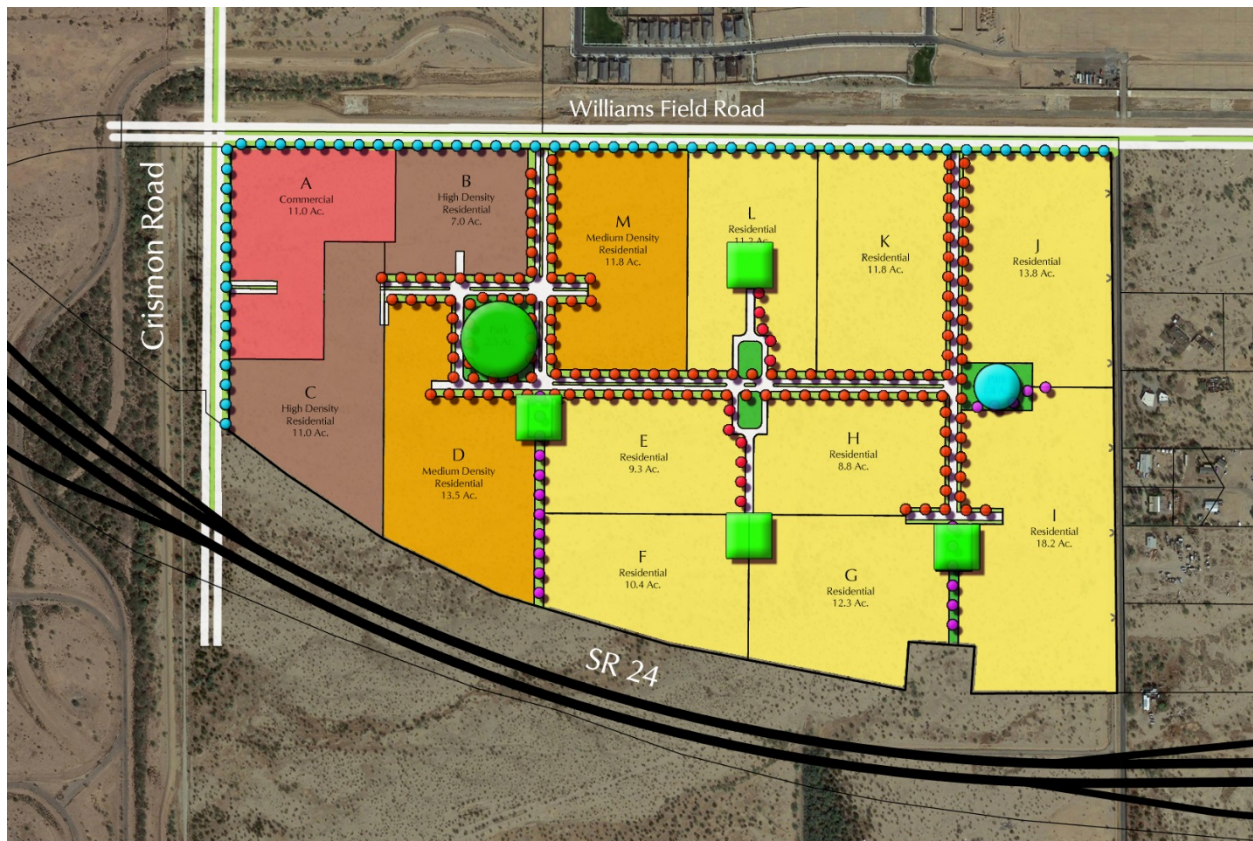

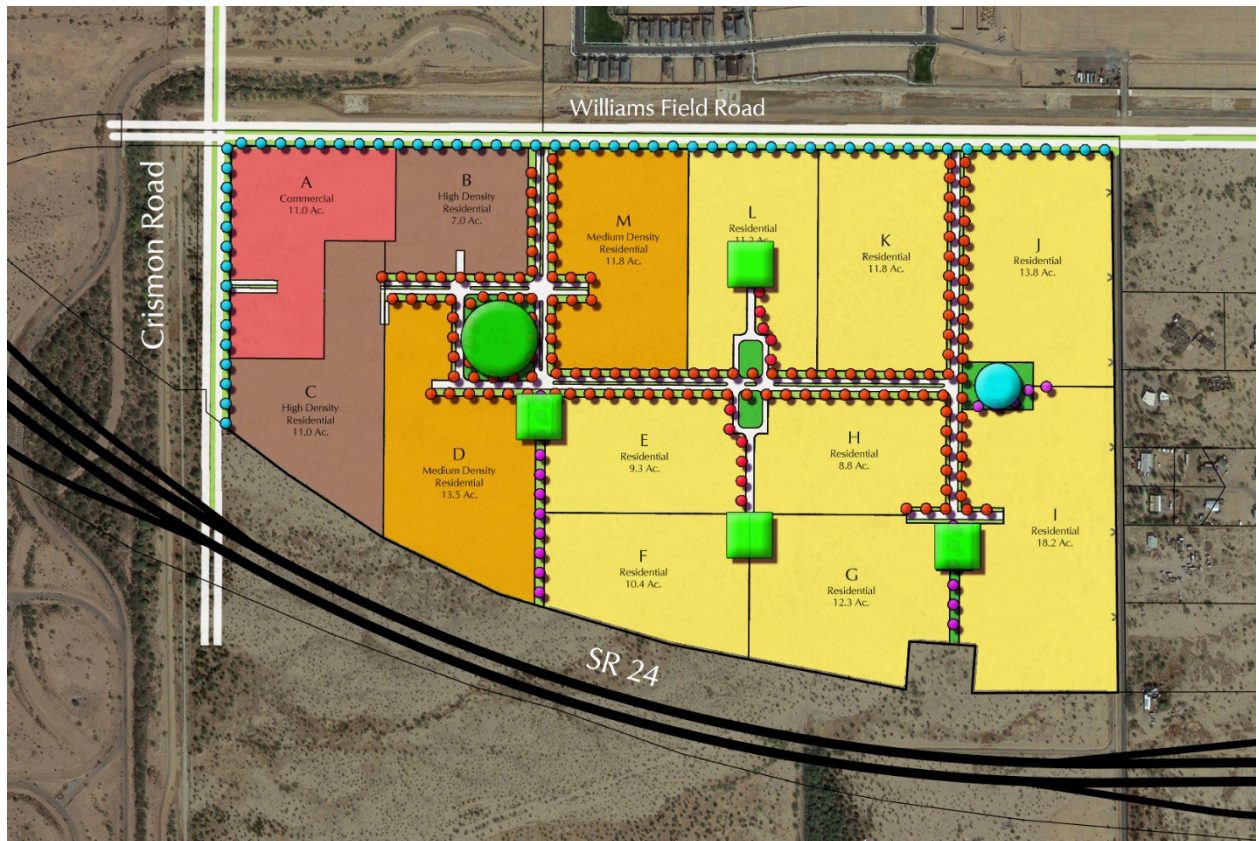
Development Unit Map
