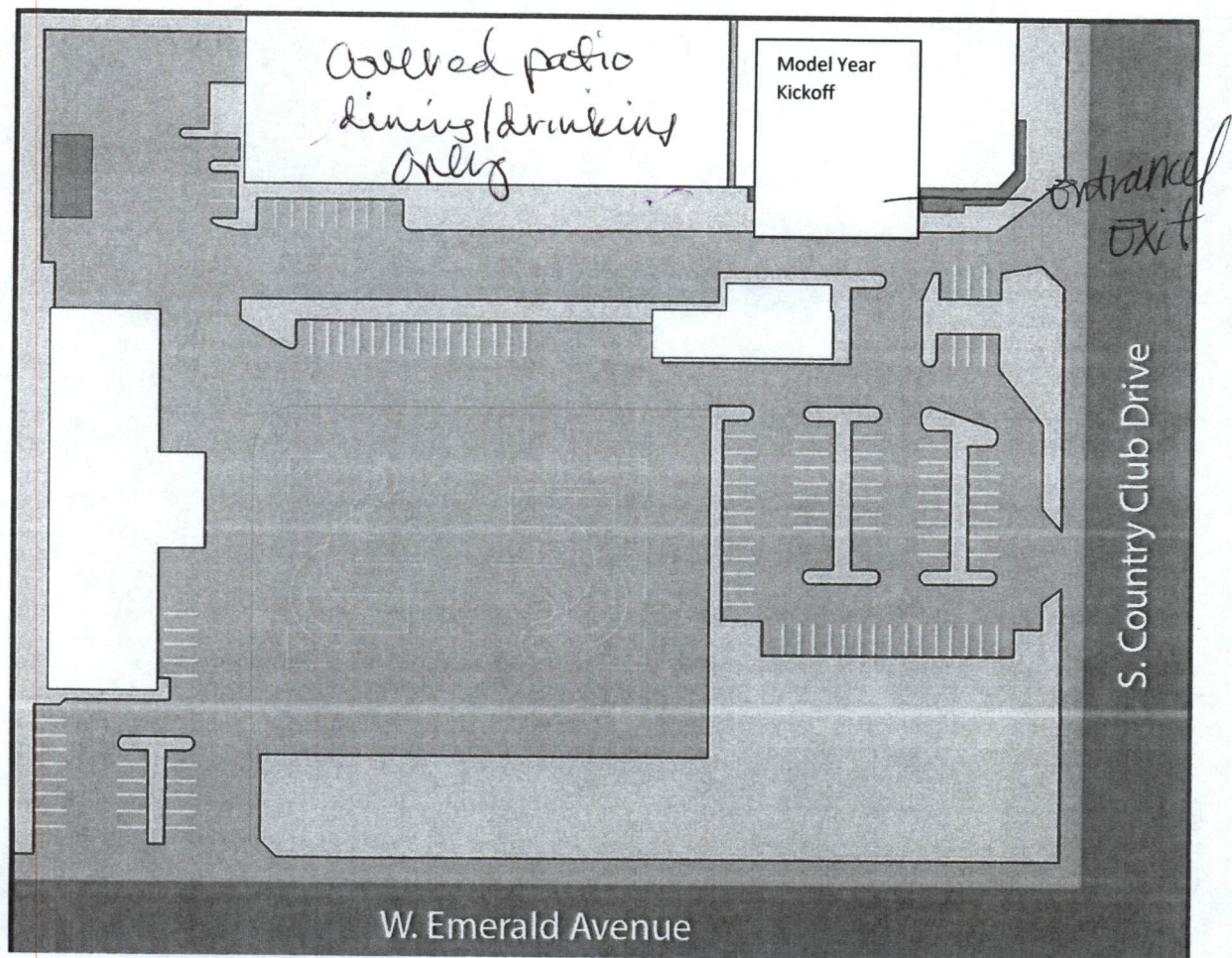

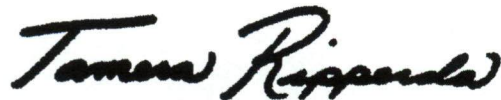
Dear Applicant:
