

**SECOND EXTENSION OF
FIRST AMENDED AND RESTATED INTERGOVERNMENTAL AGREEMENT
BETWEEN
THE CITY OF MESA, ARIZONA AND
MESA UNIFIED SCHOOL DISTRICT NO. 4 AND
THE MARICOPA COUNTY COMMUNITY COLLEGE DISTRICT
FOR
INFORMATION TECHNOLOGY AND RELATED SERVICES**

This Second Extension is to that certain First Amended and Restated Intergovernmental Agreement by and between the City of Mesa, a municipal corporation of the State of Arizona hereinafter referred to as "the City," and Mesa Public Schools, a political subdivision of the State of Arizona hereinafter referred to as "the "District," and the Maricopa County Community College District, a political subdivision of the State of Arizona hereinafter referred to as "MCCCD," dated June 21, 2012. Collectively they are referred to as "the Parties."

WHEREAS, the parties entered into that certain First Extension of the First Amended and Restated Intergovernmental Agreement by and between the City of Mesa, a municipal corporation of the State of Arizona hereinafter referred to as "the City," and Mesa Public Schools, a political subdivision of the State of Arizona hereinafter referred to as "the "District," and the Maricopa County Community College District, a political subdivision of the State of Arizona hereinafter referred to as "MCCCD," extending the term from July 1, 2014, to June 30, 2019.

WHEREAS, the City and District and MCCCD desire to extend said Agreement for another 5 years, ending June 20, 2024.

NOW, THEREFORE, it is agreed as follows:

1. Pursuant to Paragraph 2.1 "Term" in the original Agreement, all Parties agree to extend the Agreement for the second and last five (5) year term, effective July 1, 2019, through June 30, 2024.
2. All other provisions of the Agreement not specifically changed by this extension shall remain in effect and binding upon the Parties.
