#### Security Plan Outline

- I. Uniformed Security Officers on the grounds during operation.
- II. Contact with local Police Department/Sheriffs Deputies.
  - A. Hours of Operation.
  - B. Name and phone numbers of operators.
  - C. Identification of parking and security personnel.
  - D. Copy of Emergency/Evacuation Plan.
  - E. Knowledge of any changes in operation.
- III. Contact with local Fire Department.
  - A. Hours of Operation.
  - B. Name and phone numbers of operators.
  - C. Identification of parking and security personnel.
  - D. Copy of Emergency/Evacuation Plan.
  - E. Knowledge of any changes in operation.
- III. Employees/Volunteers
  - A. All employees/volunteers to have access to a two-way radio.
  - B. All employees/volunteers to be familiar with Emergency Plan: and event operations.
  - C. All employees/volunteers familiarized with fire extinguisher locations.

#### Fire Safety Plan Outline

- I. Haunted Attraction will be equipped with Four\* ABC fire extinguishers.
   A. Ticket office will also have an additional fire extinguisher.
- II. Each employee/volunteer will review the Emergency/Evacuation procedure.
- III. Each employee/volunteer will receive instruction on the operation of the fire extinguisher in their area.
- IV. No open fire or smoking will be allowed inside the attraction.
- V. Entire set will be treated with a fire retardant solution before event.
- VI. Emergency exits\* will be located throughout attraction.

<sup>\*</sup> Actual number to be determined by final location and size and Fire Marshall requirements.

## Floor Plan Outline

- I. Floor plan will be laid out to have a minimum of approximately 36" aisle widths.
- II. Some scenes will be covered with a Fire Retardant vinyl.
- III. Some Scenes will have walk through curtains also using a Fire Retardant vinyl.
- IV. Exit doors are painted the color orange, with exit signs on them.
- V. Haunted Attraction will be fully handicapped accessible.

#### Lighting Plan Outline

- There are two separate lighting circuits. I.
  - A. Theatrical lighting: includes all color lights, fog machines, and music.
  - B. Overhead Emergency lighting: includes overhead lights for emergency situations.
  - C. All Emergency Lighting is battery backup
- During operation the Emergency lights are off, and the Theatrical lighting is on. II.
- During Emergency: Ш.
  - A. All Theatrical lighting is turned off.
  - B. Overhead Emergency lighting is turned on.
- Any extension/service cords to be run along the top of the walls away from all IV. customers.

## Evacuation/Emergency Plan Outline

- I. In the event of an emergency, the door person will shut down the event.
- II. All personal and security will be notified by two-way radio of emergency.
- III. All employees/volunteers will direct customers from the event in any emergency.
- IV. All Exits marked per city regulations.
- V. Maximum occupancy of haunted attractions is 49 people or less at all times.
- VI. Separate Employee Emergency/Evacuation procedure packet "Fright Team Handbook"
  - 1) Employee training-P.A.S.S. and R.A.C.E.
  - 2) Fire Prevention plan
  - 3) Fire Emergency plan
  - 4) Medical Emergency plan
  - 5) Power Failure plan

#### Construction Detail

- I. The "set" is built with 2x3 studs.
- II. The walls are covered with OSB and plywood.
- III. All construction uses screws for assembly.
- IV. All seems, joints, caps or edges will be covered to protect customers from any sharp edges.
- V. Some Scenes are covered with Fire Retardant vinyl, along with some aisles and customer areas are covered with camouflage netting which will be treated with fire retardant solution.
- VI. Entire set treated with fire retardant solution before event.
- VII. All air lines and electrical to be run overhead as much as possible away from customers.
