Subject: Three-Year Term Contract with Two Years of Renewal Options for Large

Water Meters, Related Equipment and Parts for the Water Resources

Department (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Water Resources Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposals from Core and Main, LP; Ferguson Enterprises, LLC dba Ferguson Waterworks; Mountain States Pipe and Supply dba MSPS; and Badger Meter, Inc. dba National Meters and Automation; at \$250,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

The Water Resources Department sought proposals from qualified manufacturers along with their authorized resellers to furnish Fire System Cold-Water Meters (Group A), Fire System Non-Mechanical Cold-Water Meters (Group B), Compound Cold-Water Meters (Group C), Non-Mechanical Cold-Water Meters (Group D) and commercial/industrial service and parts (Group E).

The City received five proposals, of which, four met the minimum qualifications; one respondent was deemed as non-responsive. The evaluation committee then evaluated the four proposals based on the evaluation criteria in the solicitation. Based upon the evaluation results the evaluation committee determined the vendors that submitted the most advantageous proposal for each Group. Award is being recommended to the highest scored proposals for each Group (see Final Scoring). The evaluation committee unanimously agreed on the recommendation

National Meter and Automation was found to be non-responsive, as they did not provide all required pricing for compound meters. The City will issue an RFP for compound meters only.
