July 8, 2019

We held a Citizen Participation Meeting on July 2, 2019 in the board room of the main library, located at 61 E. 1st Street. The meeting commenced at 6:30 pm.

There were two people who attended the meeting. I gave an overview of our project, explaining that we were applying to expand two existing buildings. The front retail dispensary building to increase available product. The building in the rear of the lot was to be expanded for the purpose of becoming a cultivation and infusion facility.

There were only a few general questions asked about the project as follows:

How big were the buildings going to be?

Answer: Both would remain one story. The retail outlet would add 750 sf. and the cultivation center would be a total of 12,000 sf. Plus approximately 4,500 sf. For the infusion facility.

How would that affect parking?

Answer: The parking spaces are being reconfigured and additional spaces added to conform with city building code requirements.

What will the design of the buildings look like?

Answer: Both buildings will be updated with conservative textures and tones to improve the aesthetic appeal of the buildings. Plans have been submitted and approved by the design board.

There was no objection to the project by either citizen attending the meeting. They were appreciative of the information shared and taking the time to answer their questions. Meeting was adjourned at 7:10 pm.
