The purpose of this Citizen Participation Plan is to inform citizens, property owners, neighbor associations, agencies and businesses within 1000' of this project's location of the Denny's Restaurant. This site is located at 5854 E. Longbow Pkwy. East of N. Recker Rd. and is an application for Site Plan Review. The site has a net area of 1.9 acres and is zoned Limited Commercial with a Planned Area Development Overlay and Council Use Permit (LC-PAD-CUP). The land use is allowed under the current zoning. This plan will ensure that those affected by this application will have an adequate opportunity to learn about and comment on the proposal.

- 1. A contact list will be developed for property owners within 1,000 feet from site.
- 2. All on the contact list will receive a letter describing the project, project schedule, site plan, landscape plan, colored elevations and invitation to the Design Review Work Session.
- 3. The fact that a few individuals attended the Design Review Work Session, a neighborhood meeting will be held. An invitation to this meeting was sent Friday, October 25<sup>th</sup> to those on the previously developed contact list. Along with the Invitation Letter a reduced copy of the site plan, landscape plan and colored exterior elevations was included.
  - a. A neighborhood meeting will be conducted with an introduction to the project, an opportunity to ask questions and state concerns.
  - b. A sign-in list will be used, and comment forms provided. Copies of the sign-in list and any comments will be given to the City of Mesa Planner assigned to this project.
- 4. A Citizen Participation Report will be submitted for the Planning & Zoning Board.
  - a. The CPR will outline all efforts made to reach out the surrounding community, any feedback received, and how that feedback was addressed or resolved.
- 5. The Planning Staff has provided a list of the registered neighborhoods and HOA's that we are to send notifications to for the Planning & Zoning Hearing.
- 6. All on the contact list and the list provided by the Planning Staff will receive a letter describing the project, site plan, colored elevations and an invitation to the Planning & Zoning Hearing.
- 7. Place a notification sign at the project's property site.
