Subject:	Three-Year Term Contract with Two Years of Renewal Options for Urban Lake Maintenance for the Parks, Recreation and Community Facilities Department (Citywide)

#### Recommendation

Council is requested to approve the award as recommended.

A committee representing Parks, Recreation and Community Facilities Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposal from Aquatic Consulting & Testing, Inc., at \$36,228 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

#### **Background / Discussion**

This contract will provide urban lake maintenance including water testing and analysis, mechanical equipment maintenance and fish management for seven lakes within City boundaries. The Contractor will furnish all supervision, labor and equipment to provide lake maintenance to all City maintained urban fisheries and community lakes (Red Mountain Lake, Riverview Lake, Carriage Lane Lake, Dobson Ranch Lake, Greenfield Lake, Eastmark Lake and Emerald Park Lake).

The City solicited for Parks Urban Lake Maintenance on 9/5/2019. Proposals were due 10/3/2019. The City received four proposals of which all met the minimum qualifications. The evaluation committee scored the four proposals based on the criteria stated in the solicitation. Award is recommended to the highest scored respondent, Aquatic Consulting & Testing, Inc. The evaluation was conducted by and points were awarded by consensus by the evaluation committee. The evaluation committee unanimously agreed on the recommendation.
