

### **COUNCIL MINUTES**

February 6, 2020

The City Council of the City of Mesa met in a Study Session in the lower level meeting room of the Council Chambers, 57 East 1st Street, on February 6, 2020 at 7:31 a.m.

Mayor Giles excused Councilmember Luna and Councilmember Whittaker from the entire meeting.

### 1. Review and discuss items on the agenda for the February 10, 2020 Regular Council meeting.

All of the items on the agenda were reviewed among Council and staff and the following was noted:

Items removed from the consent agenda: None

Committeemember Thompson expressed concern related to Item 7-a, (ANX18-00788 (District 6) Annexing property located south of Elliot Road and west of Ellsworth Road (319.9± acres). Initiated by the applicant, Jordan Rose, Rose Law Group, for the owners, Stechnij H/Glenda TR/Etal, Feenstra Charles L/Barbara M TR, Robo Land, LLC./Etal, Charles Fennstra Dairy, LLC., Mesa-Casa Grande Land Co, LLC., Van Rijn Dairy, and Dairy Van Rijn.) on the Regular Council meeting agenda, that the owners of the property have not yet signed the annexation, and recommended amending the paragraph and removing Glenda H. Stechnij's name from the document.

### 2-a. Hear a presentation and discuss the work of the organization, RECOM (Retired Employees City of Mesa.)

Frank Mizner, President of Retired Employees of the City of Mesa (RECOM) displayed a Power Point presentation. **(See Attachment 1)** He commented that RECOM is a formal organization formed in 2001 and registered as a 501(c)(4) Arizona nonprofit corporation. He noted the organization has a Board of Directors with insurance, annual elections, by-laws, and policies and procedures.

Mr. Mizner stated the purpose of RECOM is to provide information, educate and advocate for the benefit of retired City of Mesa employees. (See Page 2 of Attachment 1)

Mr. Mizner pointed out the current RECOM board represents a wide range of experience from a variety of City departments and averages 24 years of service. (See Page 4 of Attachment 1)

Mr. Mizner stated several members volunteer, putting together newsletters, type meeting minutes, and attend Employee Benefits Task Force (EBTF) meetings. (See Page 5 of Attachment 1)

Mr. Mizner commented approximately 800 members participate in RECOM. He continued by saying 80% of the members live in the valley, and the remainder live out of state. (See Page 6 of Attachment 1)

Mr. Mizner explained RECOM informs, educates and advocates through:

- Monthly membership meetings
- Facebook
- RECOM Roundup Newsletter
- E-mail blasts
- Annual Spring events
- Fall Benefits meeting

Mr. Mizner commented membership dues are \$15 per year.

Mr. Mizner stated the Fall Benefits meeting includes speakers from the Arizona State Retirement System (ASRS), Public Safety Personnel Retirement System (PSPRS), Social Security Administration (SSA), and City Benefits office to inform members of any changes or updates in programs. He mentioned this year's Spring event theme is Travel Near and Far, with speakers from the Arizona Office of Tourism, Arizona Auto Association (AAA) and Howard Seftel, retired restaurant critic from the Arizona Republic as a guest speaker. Mr. Mizner commented RECOM members are encouraged to promote and be active volunteers in the community by participating in City events such as the Pre-Retirement seminar, Open Enrollment process, Wellness fair, and the City of Mesa Smoking Cessation program. He continued by stating RECOM members volunteer at the Mesa Arts Center, East Valley Martin Luther King Jr. Day parade, Point-in-Time Homeless Count, and Mesa Community College Revitalize the Rose Garden.
