Subject: Three-Year Term Contract with Two Years of Renewal Options for Scheduled and Emergency Response Electric Line Crew Services for the Energy Resources Department **(Citywide)**

Recommendation

Council is requested to approve the award as recommended.

The Energy Resources Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidders, NPL Construction Co., dba, National Powerline Construction Co.; and Wilson Utility Construction, Co.; at \$791,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

Background / Discussion

This contract will provide electric line crew services inclusive of labor and equipment for two types of work on the City of Mesa's electric distribution circuits and/or 69kV transmission facilities within the City's 5.5 square mile Electric Service Area. The two types of services are:

1. Scheduled/As-Needed Electric Line Crew services for Scheduled Construction and Maintenance Work (See Bid Responses - Pricing Sheet A)
2. Emergency Response (ER) Electric Line Crew Services for Standby/On-Call ER Repair and Maintenance Services (See Bid Responses - Pricing Sheets B – E)

There are multiple pending and active new service projects (Temple, ASU, Chicano Por La Causa and The Grid) that require multiple crews to construct the world distribution services. Electric Utility must also have electric line crew services available to respond during the monsoon season for routine outages and system damage from storm and outage events (June through September).
