Subject: Five-Year Term Contract with Two Years of Renewal Options for Motor,

Pump, and Well Maintenance, Repair and Replacement Services for the Water Resources Department and the Parks, Recreation and Community

Facilities Department (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Water Resources Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the qualified and highest scored proposals from Capital Pump and Equipment, LLC; Hennesy Mechanical Sales, LLC; Hydro-Solutions Pump and Well Services (a Mesa business); Keller Electrical Industries, Inc.; KP Venture Well Drilling & Pump Co. LLC; Laron, Inc.; Phoenix Pumps, Inc.; Pioneer Equipment, Inc.; Precision Electric Company; Pumpman Phoenix; Southwest Waterworks Contractors PM, LLC; and Weber Water Resources (a Mesa business); at \$2,825,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

Background / Discussion

This contract will provide for the purchase of pumps, motors, related equipment and parts, deep well pumps and related well equipment, repair services, rentals, and equipment for emergency pump around situations for use by the Water Resources and Parks Departments. This new contract is intended to consolidate and replace several stand-alone contracts.

Water Resources is responsible for the maintenance and operation of 35 well sites. The wells are used to supplement the water treatment facilities and to provide backup to those facilities in the event water production is reduced or cut off. It is critical that the City's wells remain in good working order and are maintained to provide optimal performance, ensuring the City of Mesa can meet customer demand under these conditions. This contract will also be utilized at water treatment, distribution, reclamation, and collection facilities ensuring the pumps and motors at those locations continue to be maintained in good working order. PRCF will utilize this contract for the repairs and replacements of pumps at various City facilities, to included aquatic facilities and City buildings.

The City received twelve proposal responses of which, all met the minimum qualifications. The evaluation committee evaluated the proposals in accordance with the City's established policies and procedures and completed the final scoring against the scoring criteria in the solicitation. Award is recommended to the qualified and highest scored respondents (See Award Recommendation). The evaluation was conducted by and points were awarded by consensus by the evaluation committee.

There will not be primary or secondary awards due to the amount of work to be done and different contractors have different lines or manufacturers authorizations for equipment and parts. When appropriate Water Resources will quote jobs/projects.
