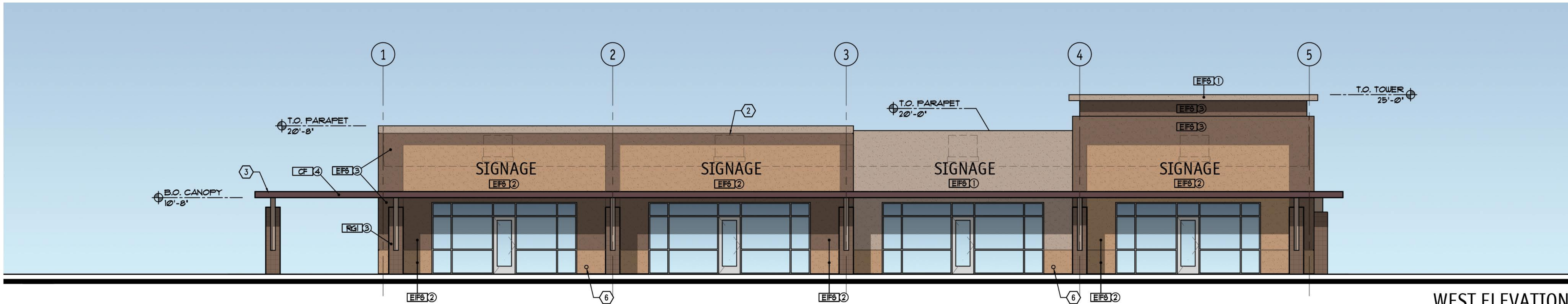
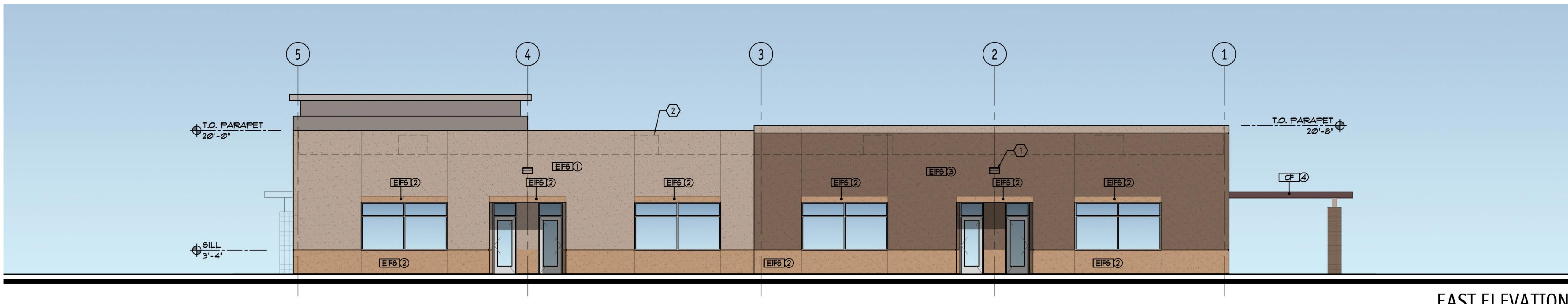


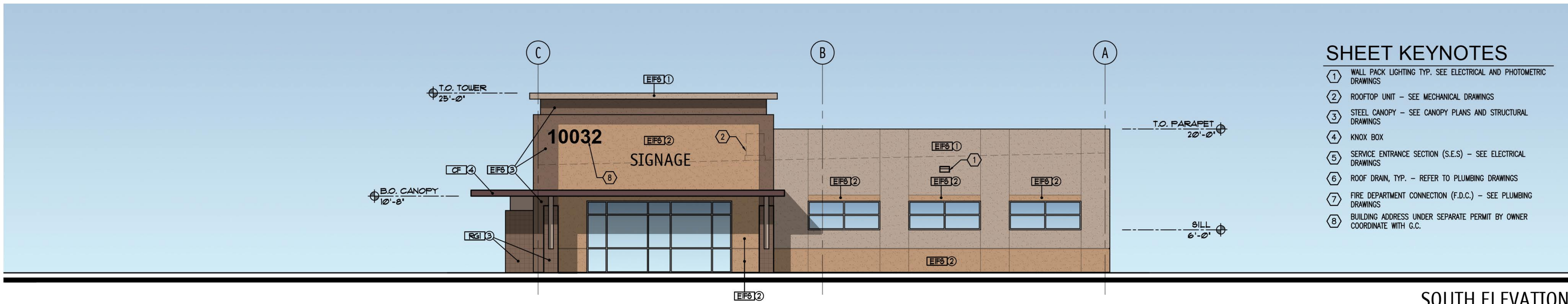
NORTH ELEVATION

2. ALL INDIVIDUAL SAMPLES TO BE PRESENTED AT ONE TIME, ONSITE IN SIZES OF NO LESS THAN 12" X 12".

NOTICE OF ALTERNATE BILLING CYCLE:

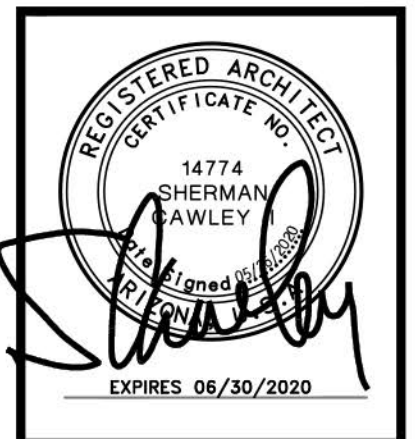
