THENCE NORTH 88 DEGREES 38 MINUTES 9 SECONDS EAST, A DISTANCE OF 28.00 FEET;

THENCE SOUTH 01 DEGREE 21 MINUTES 51 SECONDS EAST, A DISTANCE OF 12.00 FEET;

THENCE SOUTH 88 DEGREES 38 MINUTES 9 SECONDS WEST, A DISTANCE OF 8.00 FEET;


