November 9, 2015

### Review items on the agenda for the November 9, 2015 Regular Council meeting.

All of the items on the agenda were reviewed among Council and staff and the following was noted:

Items deleted from the consent agenda: None.

2-a. Hear a presentation, discuss and provide direction to the Fire and Medical Department regarding the donation of a fire pumper to the East Valley Institute of Technology (EVIT).

Assistant Fire Chief Cory Hayes and Assistant to the Fire Chief Tara Acuna addressed the Council relative to this item.

Ms. Acuna displayed a PowerPoint presentation (See Attachment 1) and reported that the East Valley Institute of Technology's (EVIT) current training apparatus is beyond repair within their budget. She noted that the Mesa Fire and Medical Department has one fire pumper truck that is available for donation upon Council's approval.

Vice Mayor Kavanaugh encouraged the Council to authorize this donation. He commented that the EVIT program is a great success and past donations have served the faculty and students well, offering them beneficial real world experience.

It was moved by Vice Mayor Kavanaugh, seconded by Councilmember Glover, to approve the donation of a fire pumper truck to the East Valley Institute of Technology.

Carried unanimously.

### 2-b. Hear a presentation and discuss the timeline of the proposed Cadence Community Facilities District formation.

Chief Financial Officer Michael Kennington introduced Scott Ruby from Gust Rosenfeld Law as the outside counsel for the Community Facilities District (CFD) and noted that a representative from Harvard Investments was also present in the audience to answer any questions Council may have.

Mr. Kennington displayed a PowerPoint presentation of the proposed Cadence CFD. (See Attachment 2) He informed Council that a petition was received for the formation of the Cadence CFD. He explained that staff has worked with the developer for the past year on the terms of the application and in accordance with Mesa's CFD guidelines and policy. He stated that staff is requesting Council consideration of the resolution for formation and approval of the development agreement and highlighted the proposed CFD timeline. In response to a question from Councilmember Richins, Tim Brislin of Harvard Investments stated that currently, Harvard Investments is the only property owner within the Cadence CFD area.

Mayor Giles commented that, although he believes a CFD is appropriate for the Cadence property, he remains unclear of the criteria necessary for another developer to attain a CFD.

Mr. Ruby explained that the City has been judicious in meeting with developers regarding CFDs, specifically focusing on those with more embellished and unique features than a basic residential subdivision. He pointed out that Cadence is unique due to its location, which is expected to be a prime employment area playing a key economic role in our community. He added that the reasons for the Cadence CFD were articulated very carefully, in an effort to minimize expectations from similar developments located elsewhere.

Mr. Ruby informed the Council that the financial basis of a CFD is to ensure that the project will be self-sustaining. He explained that the tax authorized at the election would need to be sufficient to pay for the operation and maintenance expenses of the development. He clarified that neither the City nor the developer wants to supplement that effort. He indicated that assessment bonds are more costly from an administrative standpoint, and the district will initially run at a deficit, which is why the Council is asked to approve a development agreement that requires the developer to pay those supplemental costs.

City Manager Christopher Brady asked that the Council consider the implications with two CFD developments paying higher tax rates than other City residents. He pointed out that those residents may come to the Council with questions. He suggested that it would be helpful to explain that those homeowners have a unique set of amenities that are not offered in other parts of the City.

### Facilities District (CFD) Cadence Community


**Proposed Formation Timeline**

Cadence Community Facilities District






