RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, CANVASSING, DECLARING, AND ADOPTING THE RESULTS OF THE GENERAL ELECTION CONSOLIDATED WITH THE STATEWIDE GENERAL ELECTION HELD NOVEMBER 8, 2016.

WHEREAS, on the 8th day of November 2016, the General Election of the qualified electors of the City of Mesa, Arizona, consolidated with the statewide General Election and conducted by the Maricopa County Elections Department, was held for the purposes set forth in Resolution No. 10818 and Resolution No. 10817 (Sales Tax); and

WHEREAS, the election returns have been presented to and have been canvassed by the City Council of the City of Mesa on this 1st day of December, 2016, and the Maricopa County Final Official Results of the General Election are attached hereto and incorporated herein; and

WHEREAS, the reports of the election boards as canvassed show that there were 179,159 ballots cast; and

WHEREAS, the number of votes cast for each District 2 candidate is as follows:

WHEREAS, the number of votes cast for the measure that appeared on the ballot as follows:

WHEREAS, at the General Election, JEREMY WHITTAKER received a number of votes constituting a majority of all of the valid ballots cast for the office of Councilmember – District 2 and is hereby issued a certificate of election; and

WHEREAS, at the General Election, Question 1 – Transaction Privilege (Sales) Tax is declared to be rejected by the voters; and

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA, AS FOLLOWS:

<u>Section 1</u>. That JEREMY WHITTAKER is declared to be elected to the office of Councilmember – District 2.

Section 2. That QUESTION 1 is declared to be rejected by the voters.
