Authorizing the issuance of the District's General Obligation Bonds, Series 2019; approving the form and authorizing the execution and delivery of various documents related thereto; ratifying and approving a preliminary official statement and approving a final official statement relating to the bonds; levying an ad valorem tax on taxable property in the district; awarding the bonds to the purchaser thereof; appointing a registrar, transfer agent and paying agent for the bonds; and taking other actions securing the payment of and relating to the bonds.

It was moved by Boardmember Thompson, seconded by Boardmember Freeman that Resolution No. CFD CD Res 13 be adopted.

Chairman Giles declared the motion carried unanimously by those present and Resolution No. CFD CD Res 13 adopted.

4-c
