1. Review and discuss items on the agenda for the August 19, 2019 and August 26, 2019 Regular Council meetings.

All of the items on the agenda were reviewed among Council and staff and the following was noted:

Conflict of interest: Vice Mayor Freeman declared a conflict of interest on items 12-b and 12-c on the August 19, 2019 Regular Council Meeting agenda and will refrain from discussion/consideration of these items.

Items removed from the Agenda: None

Library Director Heather Wolf discussed Item 4-a (Purchase to Configure Eight Study/Meeting Rooms (Additions) at the Main Library as requested by the Library Services Department (District 4)) on the Regular Council Meeting agenda for August 26, 2019. She mentioned adult services and adult computers will be moved to the second floor where all other adult collections reside. She advised there will be six meeting rooms for up to four people, and two larger rooms that hold up to twelve people. She continued by stating another contract will be submitted to buy new furniture to improve the function of the second-floor renovations. She explained freeing up the space on the first floor creates room to renovate and expand the children's area, making it family friendly.

Airport Director Corinne Nystrom discussed Item 4-m (Mesa-Falcon Field Airport Runway Connecting Taxiways Project (District 5)) on the Regular Council Meeting agenda for August 26, 2019. She indicated Council previously approved a Federal Aviation Administration (FAA)

grant to construct acute angle taxiways on the north side of the North runways. She stated all grants have come through and construction will begin soon. She explained the reasoning for acute angle taxiways is to facilitate getting aircraft off the runway quickly.

In response to a question from Councilmember Luna, Ms. Nystrom responded by stating there will be some short runway closures on the North runway, but mostly at night.

In response to a question from Mayor Giles, Ms. Nystrom replied that the new runways will also help with the traffic once the new hangars being built along the north side are completed.

Vice Mayor Freeman pointed out changes are coming to the City of Mesa nuisance codes due to complaints.

Mayor Giles thanked staff for the information.
