The City Council of the City of Mesa met in a Special Council Meeting via a virtual format streamed into the Council Chambers, 57 East 1st Street, on May 18, 2020 at 6:30 p.m.

Mayor Giles conducted a roll call.

1. Conduct a public hearing on the proposed Fiscal Year 2020-21 Budget and the proposed Fiscal Year 2020-21 Secondary Property Tax Levy, and take action on the Fiscal Year 2020-21 Budget.

- 1-a. A public hearing on the proposed Fiscal Year 2020-21 Budget and the proposed Fiscal Year 2020-21 Secondary Property Tax Levy.

Mayor Giles announced that this was the time and place for a public hearing regarding the proposed Fiscal Year 2020-21 Budget and the proposed Fiscal Year 2020-21 Secondary Property Tax Levy.

Councilmember Whittaker expressed his opposition to the budget due to the Government Finance Officers Association (GFOA) recommendation of a 16% reserve balance, the structural imbalance of the budget, and his concerns about the effect that the Arizona State Retirement System (ASRS) and Public Safety Personnel Retirement System (PSPRS) will have on the budget.

There being no citizens present wishing to speak on this issue, the Mayor declared the public hearing closed.

- 1-b. A resolution approving the budget for the Fiscal Year ending June 30, 2021. – Resolution No. 11513

It was moved by Councilmember Luna, seconded by Vice Mayor Freeman, that Resolution No. 11513 be adopted.
