**Date of report:** August 6, 2024

**Overview:** This report provides progress update of the implementation of the citizen participation plan for the Walmart Fuel Station Site number 1646. This is located at 6131 E Southern Ave, Mesa, AZ 85206. This is an application for the development of 0.84 acres of the existing Walmart lot. This report provides evidence that citizens, neighbors, public agencies and interested persons have had adequate opportunity to learn about and comment on the proposed plans and actions addressed in this application. **Results:**

There are 226 persons on the 1000-foot contact list as of the date of this Citizen Participation Report (see attached). The preliminary neighborhood outreach meeting was held via teams on Monday August 5<sup>th</sup> at 6:00 P.M. There were three attendees present during the call, two of which were residents of the leisure world community just North of the site, the other was a resident of the Parklinks condominium complex on the southwest corner of the Walmart supercenter property. A number of concerns were raised and addressed to the extent applicable by Kimley-Horn and the City of Mesa staff members. Those concerns included general impacts to the adjacent communities/neighborhoods, increases in HOA fees, decrease in property values, increases in crime, noise increases, and visibility of new signage for the fuel station. The residents were assured that the development of the Walmart fuel station was following all guidelines laid out for development of fueling stations by the City of Mesa. Participants were informed of the planning and zoning process for the project and made aware of the hearing date and opportunity to further discuss their concerns before the committee. No one has contacted us as of the date of this Report.
