

RESOLUTION NO. 12097

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA APPROVING AND AUTHORIZING THE CITY MANAGER TO ACCEPT PROPOSITION 202 FUNDS FROM THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY AND ADMINISTER AWARDED FUNDS AS PASS-THROUGH GRANTS TO DESIGNATED AWARDEES.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA AS FOLLOWS:

Section 1: Arizona's Indian Gaming Compact provides that an Indian Tribe make twelve percent (12%) of its net annual State contribution to cities, towns or counties for government services that benefit the general public. Private, not-for-profit organizations wishing to access Indian Gaming Funds ("Gaming Funds") to provide public benefits must secure sponsorship from a city, town or county before making application. This sponsorship must be expressed in a resolution passed by the local government sponsor.

Section 2: The Salt River Pima-Maricopa Indian Community wishes the City of Mesa to receive and distribute \$1,120,000.00 from its 2024 12% revenues for grants as follows:

- \$200,000.00 to **A New Leaf** for homeless and domestic violence shelter services.
- \$ 50,000.00 to **U.S. Vets – Phoenix** to support mental health services for homeless and at-risk veterans. Funding would be used to expand services in Maricopa County.
- \$ 100,000.00 to the **Child Crisis Center** for Educating Caregivers to Keep Children Safe program. Programming will focus on family Education and the FANS distribution center.
- \$ 50,000.00 to **Alice Cooper's Solid Rock Teen Center** for programming of A Safe and Creative Space for Teens. The goal to provide teens with skill building, job mentoring, job placement, and develop is to build skills, be mentored, and develop artistic skills in music, dance, photography, etc.
- \$ 20,000.00 to **Visit Mesa** for the Mesa Nightlife and Events Campaign to market the growing nightlife activities in Mesa.
- \$175,000.00 to the **United Food Bank** for the Emergency Food Assistance Produce Box Program.
- \$300,000.00 to the **City of Mesa** for five governmental programs. Fire and Medical Department – Immunization Program; Environmental and Sustainability - Trees for Heat Mitigation; City Manager's Office, Special Projects – MacDonald Plaza Pilot Project, Mesa K-Ready – Kindergarten Readiness Program; and Arts and Cultural Department, Mesa Arts Center – MCA

Disadvantaged Artist Support.

\$ 75,000.00 to the **Arizona Museum of Natural History** for an internship initiative to train science professionals in an inclusive environment.

\$150,000.00 to **Sun Life Health** for the purchase of an automated medicine dispenser unit.

Section 3: The City Council supports these grants and authorizes the City Manager, or his designee, to accept and administer the 2024 awarded Salt River Pima-Maricopa Indian Community Proposition 202 funding.

Section 4: Approval by the City Attorney or designee and signature by the City Manager or designee of the Intergovernmental Agreement, and any related amendments or supplements thereto, shall constitute conclusive evidence of this City Council's approval thereof.
