Subject: Use of a Cooperative Contract for the Purchase of One Aerial Bucket Truck

(Addition) for the Fleet Services and Transportation Departments (Funded by

Local Street Sales Tax) (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Fleet Services and Transportation Departments and Procurement Services recommend authorizing the purchase using the Sourcewell cooperative contract with Altec Industries, at \$420,000, based on estimated requirements.

Background / Discussion

This additional bucket truck will ensure the department has adequate spare units in its fleet to support Transportation's Streetlight and ITS workgroups. The truck will be used to maintain over 45,000 streetlights and 400 traffic signals located throughout the City.

The Sourcewell cooperative contract has been competitively bid and meets the City's procurement requirements. Utilizing the Sourcewell contract allows the City to receive competitive rates based on a formally solicited agreement. The City believes the pricing is fair and reasonable and soliciting for this product would not result in the City receiving more favorable pricing or terms. The manufacturer has confirmed the Sourcewell contract offers the most favorable pricing available in the country for Altec products.
