

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA AMENDING SECTIONS 10-4-4 AND 10-4-5 OF THE MESA CITY CODE PERTAINING TO SPEED LIMITS WITHIN THE CITY LIMITS OF MESA; AND PROVIDING CIVIL SANCTIONS FOR THE VIOLATION THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: That Section 10-4-4 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of forty (40) miles per hour:

Broadway Road, East	From South Stapley Drive to South Gilbert Road;
Broadway Road	From GILBERT ROAD Country Club Drive to Mulberry;
Center STREET North	From a point six hundred forty feet (640') north of 8th Street UNIVERSITY DRIVE to Brown Road;
Country Club Drive	From Baseline Road to the east leg of 2nd Avenue; From University Drive BASELINE ROAD to Brown Road;
Mesa Drive, South	From East Broadway Road BROWN ROAD to the south City limits;
Stapley Drive	From BROWN ROAD East Broadway Road to East Southern Avenue;
Stapley Drive, North	From University Drive north to East Brown Road;

~~University Drive, East~~ ~~From North Stapley Drive to South Gilbert Road;~~
 University Drive, West From **GILBERT ROAD** Standage to the west City limits;

Section 2: That Section 10-4-5 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of thirty-five (35) miles per hour:

~~Broadway road~~ ~~From Stapley Drive to Country Club Drive;~~
 Center **STREET**, North From 1st Street to a point six hundred forty feet (640') north of 8th Street **UNIVERSITY DRIVE**;
~~Country Club Drive~~ ~~From the east leg of 2nd Avenue to University Drive;~~
 Mesa Drive ~~From Broadway Road to Brown Road and from McKellips Road to Lehi Road;~~
 Stapley Drive ~~From East Broadway Road north to East University Drive;~~
 University Drive ~~From Standage to Stapley Drive;~~

Section 3: Civil Traffic Violations: Any violation of or failure or refusal to do or perform any act required by the provisions of this ordinance or of the Mesa City Code as amended herein shall constitute a civil traffic violation.
