Subject: Three-Year Term Contract with Two Years of Renewal Options for Employee

Uniform Garments for Citywide Departments (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Water Resources, Parks, Recreation and Community Facilities and Engineering Departments, and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposals from Ace Uniforms of Phoenix (Primary); and Mission Uniform Supply (Secondary); at \$375,000 annually, with an annual increase allowance of up to 5% or the adjusted Producer Price Index.

Background / Discussion

Through its uniform purchase program (Uniform Garment Program), the City purchases and issues garments to employees and the employees are responsible for the laundry and maintenance. Items include t-shirts, polo shirts, jeans and shorts; traditional poly/cotton and cotton uniform shirts and pants; and jackets, hats and ball caps. Departments using this contract include Arts and Culture, Business Services, Development Services, Economic Development, Energy Resources, Engineering, Environmental Management and Sustainability, Fleet Services, Innovation and Technology, Parks, Recreation and Community Facilities, Transportation, and Water Resources. All departments may use the contract. Mesa Fire and Medical has a separate contract.

The City received three proposal responses of which all vendors met the minimum qualifications. The evaluation committee evaluated the proposal in accordance with the City's established policies and procedures. The committee agreed to shortlist the top two ranked offerors, Ace Uniforms and Mission Linen. The evaluation committee completed scoring the response against the scoring criteria in the solicitation. Based upon the evaluation results, the committee recommends award to the highest scored respondents, Ace Uniforms of Phoenix (Primary); and Mission Uniform Supply (Secondary); the topranked firms whose proposals best meets the City's requirements.
