Subject:	One-Year Renewal to the Term Contract for Water and Wastewater Equipment Repairs and Maintenance for the Water Resources Department (Citywide)

## Recommendation

Council is requested to approve the contract renewal as recommended.

The Water Resources Department and Purchasing recommend authorizing the renewal using the City of Chandler cooperative contract with DXP Enterprises, Inc.; Foster Electric Motor Service, Inc.; Hennesy Mechanical Sales, LLC; James, Cooke & Hobson, Inc.; Layne Christensen; Phoenix Pumps, Inc.; Southwest Waterworks Contractors, Inc.; and Weber Water Resources, LLC; at \$800,000 annually, based on estimated usage.

## **Background / Discussion**

Water Resources utilizes this contract as a supplement to four existing contracts for Vertical Turbine Pumps Repairs, Submersible Pump/Motor Repairs, Well and Well Pump Repairs, and Electric Motor Rewinds and Repairs. The City of Chandler awarded this contract to several vendors that the City does not currently have under contract. Water Resources would like to award to the same vendors ensuring availability of qualified contractors to meet the City's various needs for compatible parts and experienced labor.

This contract allows the City more flexibility to quote larger repairs with other vendors and to quote the purchase of new pumps and motors with more vendors. One main use is being able to send Flygt Pumps to James, Cooke & Hobson for repairs as they are the *only* authorized manufacturer rep for these pumps, and the same for Hennessy Mechanical, as they are the sole rep for several manufacturers' equipment that the City currently has in place.

The aforementioned vendors have agreed to renew the contract maintaining last year's pricing. The City has been satisfied with each vendor's performance and the contractors continue to meet expectations and requirements. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

This contract will be re-solicited and awarded as part of a larger contract before the contract expires in 2020. The City is currently rewriting the specifications for a new Request for Proposal for Water and Wastewater Equipment Repairs that will include all types of pumps and motors.
