

Citizen Participation Report for Southgate Commerce Park Case # ZON24-00030

Overview: This report provides results of the implementation of the Citizen Participation Plan for Southgate Commerce Park. This site is located at 8830 E Germann Road, Mesa, AZ and is an application for a Rezone from Office Commercial with a Planned Area Development Overlay (OC-PAD), Neighborhood Commercial with a Planned Area Development Overlay (NC-PAD) and Light Industrial with a Planned Area Development Overlay LI-PAD) to OC-PAD, NC-PAD and LI-PAD to modify the existing PAD to allow for phasing of the proposed business park. This report provides evidence that citizens, neighbors, public agencies, and interested persons have had adequate opportunity to learn about and comment on the proposed plans and actions addressed in the application. There were 122 addresses on the contact list that represent 118 properties as of the date of this Citizen Participation Report (see attached)

 - a. Minimize lighting at night.
 - b. Contractors driving in residential streets.

- c. Trash and disposal of materials to keep area free of blown items into neighborhoods.
 - d. Noise needs to be at a minimum.
2. How concerns issues and problems were addressed:
- a. Existing site lighting is installed and will not be changed. No spotlights will be included in the project.
 - b. There is no need to have contractors using residential streets to the west. Development has its own entrance that will be utilized for construction.
 - c. Trash is to be hauled off or a dumpster is to be placed on construction sites to maintain cleanliness around the construction site.
 - d. The current tenants are office users that will leave at normal business hours. One current tenant is a restaurant that has been operating for several years and has had no complaints about them.
3. Concerns, issues, and problems not addressed and why:
- a. All the concerns of attendees were addressed.

Purpose: The purpose of this Citizen Participation Plan is to inform citizens, property owners, neighborhood associations, agencies, schools, and businesses in the vicinity of the site of an application for the Southgate Commerce Park. This site is located at 8830 E. Germann Road and is an application for minor revisions to site plan landscaping and to allow a phased construction for the project. This plan will ensure that those affected by this application will have an adequate opportunity to learn about and comment on the proposal.

Pre-Submittal Conference: The Pre-submittal Conference with City of Mesa Development Services staff was held on 14 September 2023. Staff reviewed the application and recommended that adjacent residents, the Mesa School District, and nearby registered neighborhoods be contacted.

Action Plan: In order to provide effective citizen participation in conjunction with this application, the following actions will be taken to provide opportunities to understand and address any real or perceived impacts that members of the community may have.

1. A contact list will be developed for citizens and agencies in this area including:
 - a. All registered neighborhood associations within one mile of the project.
 - b. Homeowners Associations within one half mile of the project.
 - c. Interested neighbors - focused on 500 feet from site but may include more.
 - d. Mesa Public School District or Gilbert Public School District, in writing, with copies to the high schools, middle schools, jr high schools and elementary schools, who may be affected by this application.
2. All persons listed on the contact list will receive a letter describing the project, project schedule, site plan, and invitation to a series of a neighborhood meeting to be held at TBD.
 - a. The meeting will be an introduction to the project, and opportunity to ask questions and state concerns. A sign-in list will be used and comment forms provided. Copies of the sign-in list and any comments will be given to the City of Mesa Planner assigned to this project. As questions arise after the meeting they will be reviewed and an individual response will be given.
3. Presentations will be made to groups of citizens or neighborhood associations upon request.

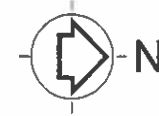

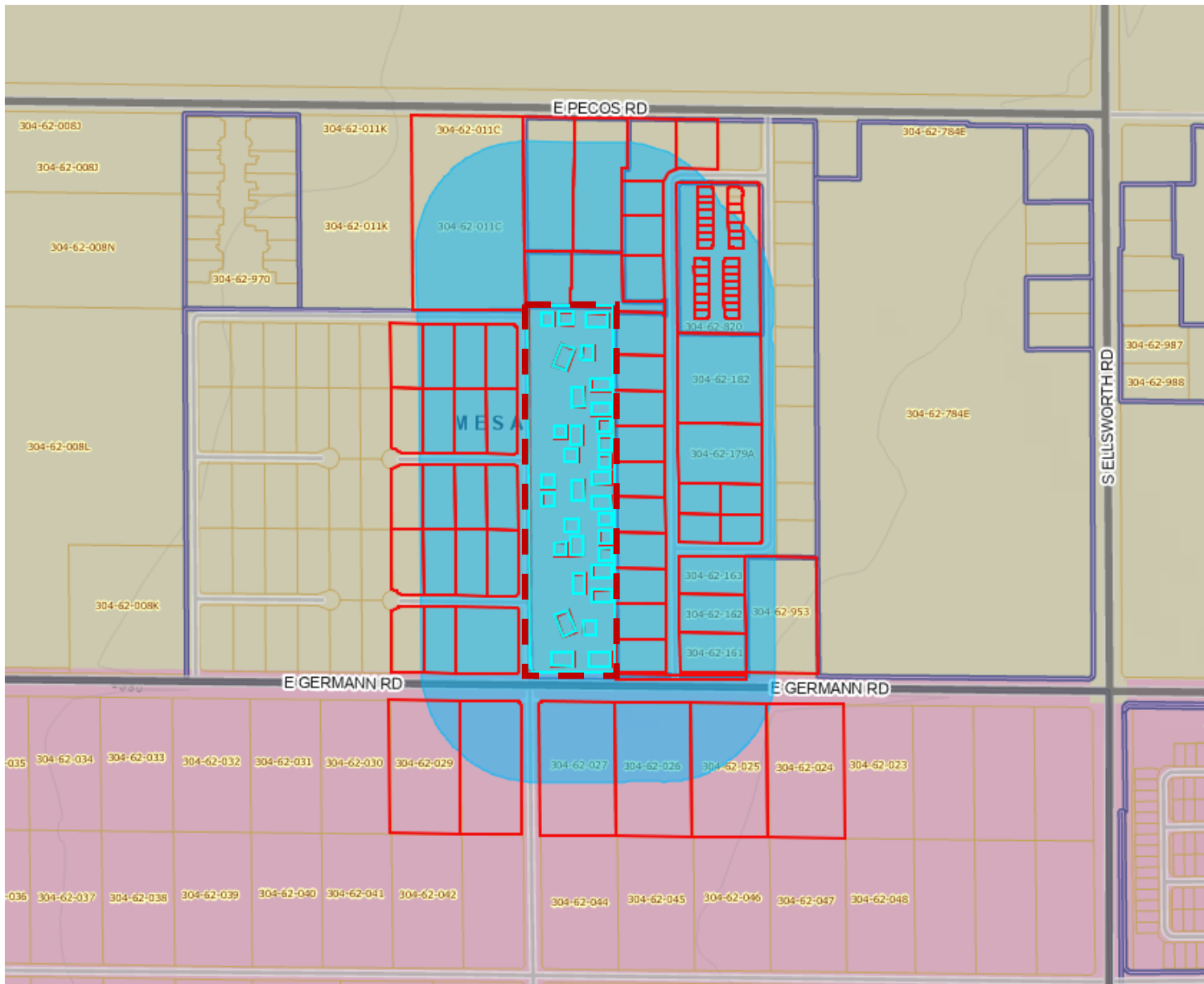

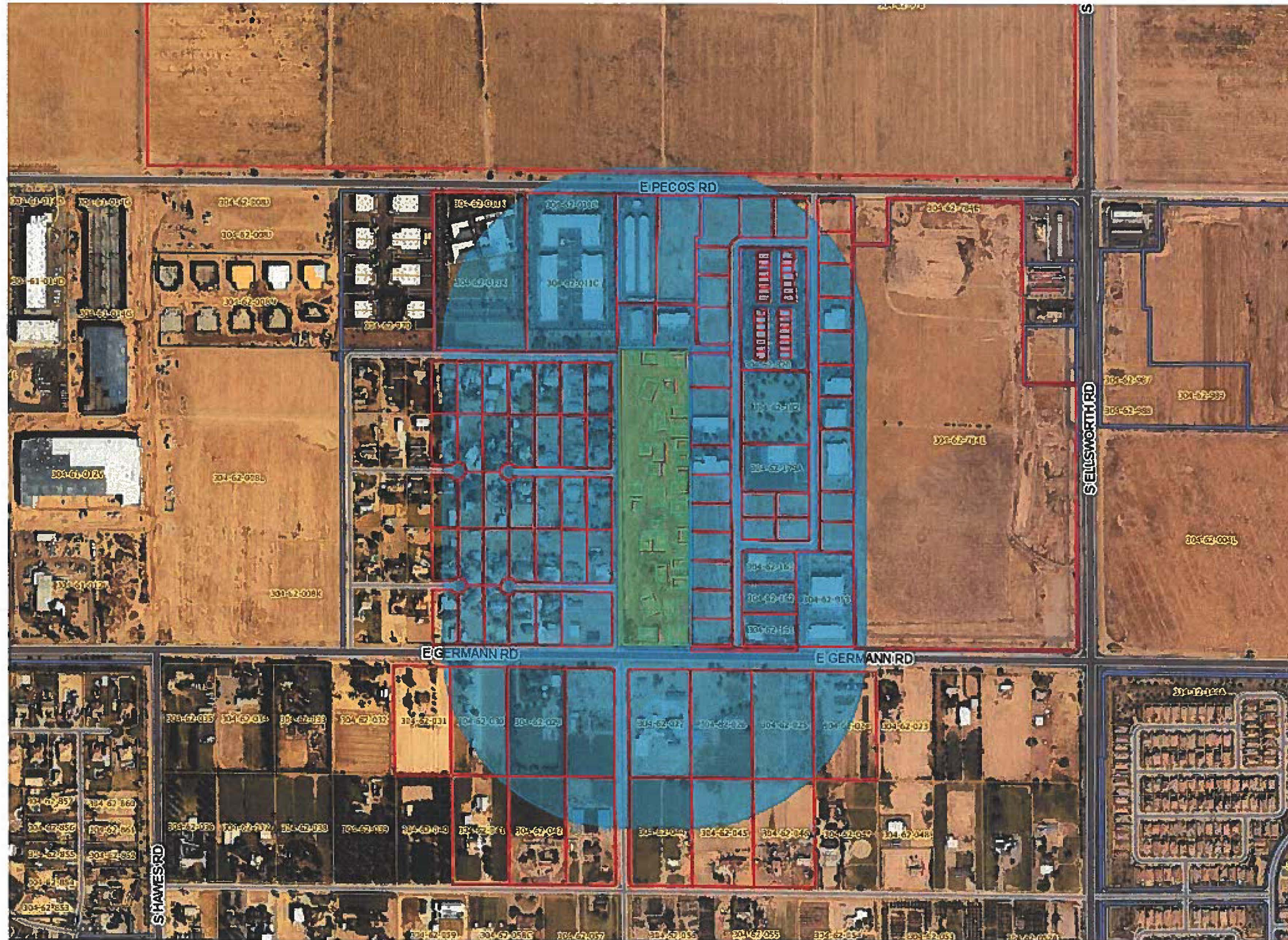
