1. Chair's Call to Order.

Ms. Hammond called the meeting to order at 6:00 p.m.

4. Hear and discuss presentation on the purpose and function of the HRAB, Arizona Open Meeting Law, and working with the media.

Ms. Lauren Lowe, Assistant City Attorney, presented to the Board a summary of the Board's role, the Open Meeting Law, along with working with the media. She explained how the Board was created, its structure, and purpose it serves in tandem with Council. She also provided the explanation of the Open Meeting Law to the Board and how it impacts the Board's processes. Ms. Lowe also provided the Board guidance about working with the media per City policies and key information about media processes. She concluded her presentation by addressing questions and responding to feedback from the Board.



5. Hear and discuss a presentation on the 2025-2027 drafted HRAB Strategic Plan, including the mission, vision, strategic goals and annual workplan for HRAB.

Ms. Andrea Alicoate, Assistant to the City Manager, shared with the Board the drafted 2025-2027 Strategic Plan for the Human Relations Advisory Board. She reviewed the items summarized within the document based on past discussions and feedback from the Board during the March and April 2025 board meetings. She highlighted the development of the key measurements in the new plan and emphasized that the public is welcome to observe and participate in the meetings. Ms. Alicoate answered questions and responded to feedback provided by the Board.
