**Subject:** Five-Year Term Contract for Water/Wastewater Corrosion Monitoring and

Testing Services for the Water Resources Department (Citywide)

#### Recommendation

Council is requested to approve the award as recommended.

A committee representing the Water Resources Department and Procurement Services evaluated responses and recommend awarding the contract to the highest scored proposals from Accurate Corrosion Control, Inc., Corrpro Companies, Inc., and Farwest Corrosion Control Company at \$350,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

### **Background / Discussion**

This contract will establish a list of qualified contractors who will provide services related to corrosion monitoring and cathodic protection systems. These services will include annual inspection, testing, routine maintenance, and minor repairs. Regular corrosion monitoring and cathodic protection are essential to prolonging the lifespan of metal components in the City's utility systems, reduce service disruptions, and prevent costly structural failures. The contractor's services will support the City's commitment to maintaining safe, efficient, and sustainable water and reclaimed water operations for the community.

City staff issued a Request for Proposal (RFP) to all registered and known Water and Wastewater Monitoring and Testing Services Providers. Six proposal responses were received, all of which met the minimum requirements and were evaluated and scored in accordance with the City's established policies and procedures and relative to the scoring criteria in the solicitation. Based on the evaluation results, the committee recommends awarding the contract to the highest-scoring respondents.
