AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA ADOPTING TITLES AND SCHEDULES OF TERMS, RATES, FEES AND CHARGES FOR CITY-OWNED WASTEWATER UTILITIES
