The presubmittal conference took place on 2 May 2023 where the application was reviewed by staff, and it was recommended that community members be contacted.

Action Plan:

In order to provide effective citizen participation in conjunction with this application, the following actions will be taken to provide opportunities to understand and address any real or perceived impacts that members of the community may have.

1. A contact list will be developed for citizens and agencies in this area including:
 - a. All registered neighborhood associations within one mile of the project.
 - b. Homeowners Associations within one half mile of the project.
 - c. Interested neighbors - focused on 1,000 feet from site but may include more.
2. All persons listed on the contact list will receive a letter describing the project, project schedule, site plan, and invitation to a series of two neighborhood meetings to be held at Pink Jr. High.
 - a. The first meeting will be an introduction to the project, and an opportunity to ask questions and state concerns. A sign-in list will be used and comment forms provided. Copies of the sign-in list and any comments will be given to the City of Mesa Planner assigned to this project.
3. Presentations will be made to groups of citizens or neighborhood associations upon request.

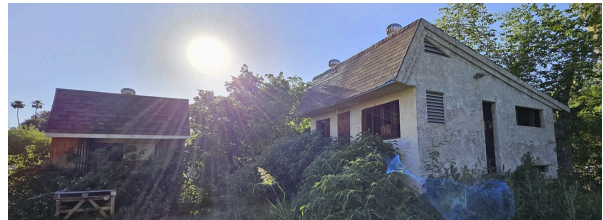
Lofts at 121 N Beverly - Townhome Development Community Meeting



Dear Neighbor,

Our client is interested in developing his childhood home lot, and the lot next to it, into a multifamily project. This townhouse project aims to provide the comforts and qualities of a single family home, with 3 bedroom units, large kitchens, laundry rooms, and 2 car garages. The surrounding neighborhoods house generations of families, and many who live there seek places for their children to live, or to retire in when it's time to downsize or spend less time mowing the lawn.

The architecture of the units is inspired by the pigeon lofts currently located on the property, as seen in this photo. The developer's father, a longtime Mesa resident, kept pigeons his entire life. The unique shape of the pigeon loft roofs and vents are a historical, local cultural element that inspired the roof shape and other design elements of this project.



These townhomes are adjacent to Beverly Park, and will add additional lighting along the border of that park. This is to help the park to become a safer and more desirable place to recreate for everyone. The townhomes are 30' or more from the wall along the north side, with landscaping designed with large trees to keep those neighboring yards out of view from the townhomes. Each unit has a 2 car garage, and there are 18 additional parking spaces on the site to ensure parking doesn't spillover into the neighborhood.

Community Meeting Letter

8.26.2024

LOFTS AT BEVERLY NEIGHBORHOOD MEETING NOTES

September 5, 2024

Discussion Points

- **Residents appreciated design elements honoring the property's history and heritage**
 - Request: find additional elements beyond the “loft” concept to tie to historical nature of property, possible entry feature or other historic element(s)
 - Additional request to retain portion of block fencing containing an artistic mural facing the park

- **Main resident concern was density and unit count due to: i) increased traffic, ii) possibility of accidents at intersection of 2nd & Beverly, and iii) congestion caused by overflow parking**
 - Mitigation efforts:
 - offer traffic study to show true impact of additional units
 - consider parking area on neighboring park property
 - restrict parking in front of the project
 - request speed humps on Beverly to curb speed and traffic flow
 - consider additional street signage to reduce traffic risks at intersection

- **Concern about lack of foliage increasing the heat signature of the area and losing some of the current “screening” effect of thick plant growth**
 - Mitigation efforts:
 - Discuss shade tree varieties with landscape architect
 - Discuss amending tree type on north boundary to a more dense foliage variety
 - Discussed request for parks & rec to allow additional tree plantings (or transplanting of trees from site) on and within park boundaries

- **Concern about a family of foxes that have been seen at the Property**
 - No mitigation efforts discussed, was more a passing comment

- **Discussion about improving park safety and if design will help with security and oversight of transient/drug activity at the park**
 - Mitigation efforts:
 - South facing units on park boundary to provide better visibility of park activity
 - View fencing to allow visibility of park activity from resident properties
 - Added lighting on south boundary with park to increase night illumination of the area
 - Many neighbors seemed much more supportive of the project in general if additional improvements to the park security and possibly amenities could be incorporated
 - Most residents were aware of illegal activity at the park and were hopeful the project could help mitigate such activity

- **Discussion about development process**
 - Neighbors were informed about how they can participate and voice concerns throughout the site plan, design review, zoning, and council process

January 7, 2025

Approximately 12 neighbors in attendance.

Discussion Points

- **Report results of Traffic Study findings in response to neighbor concerns**
 - Findings:
 - Traffic impact was nominal and did not meet thresholds for speed bump/hump remediation
 - Reviewed proposal to Parks & Recreation regarding new parking lot on park property that was rejected
 - Explained traffic flow on-site and how north egress is for emergency egress and city facilities only

- **Park Safety**
 - Prior meeting residents were concerned about illegal/illicit activities at park:
 - Explained site plan and orientation of southern units to gain greater visibility to the park and lighting design to illuminate dark/less visible portions of the park

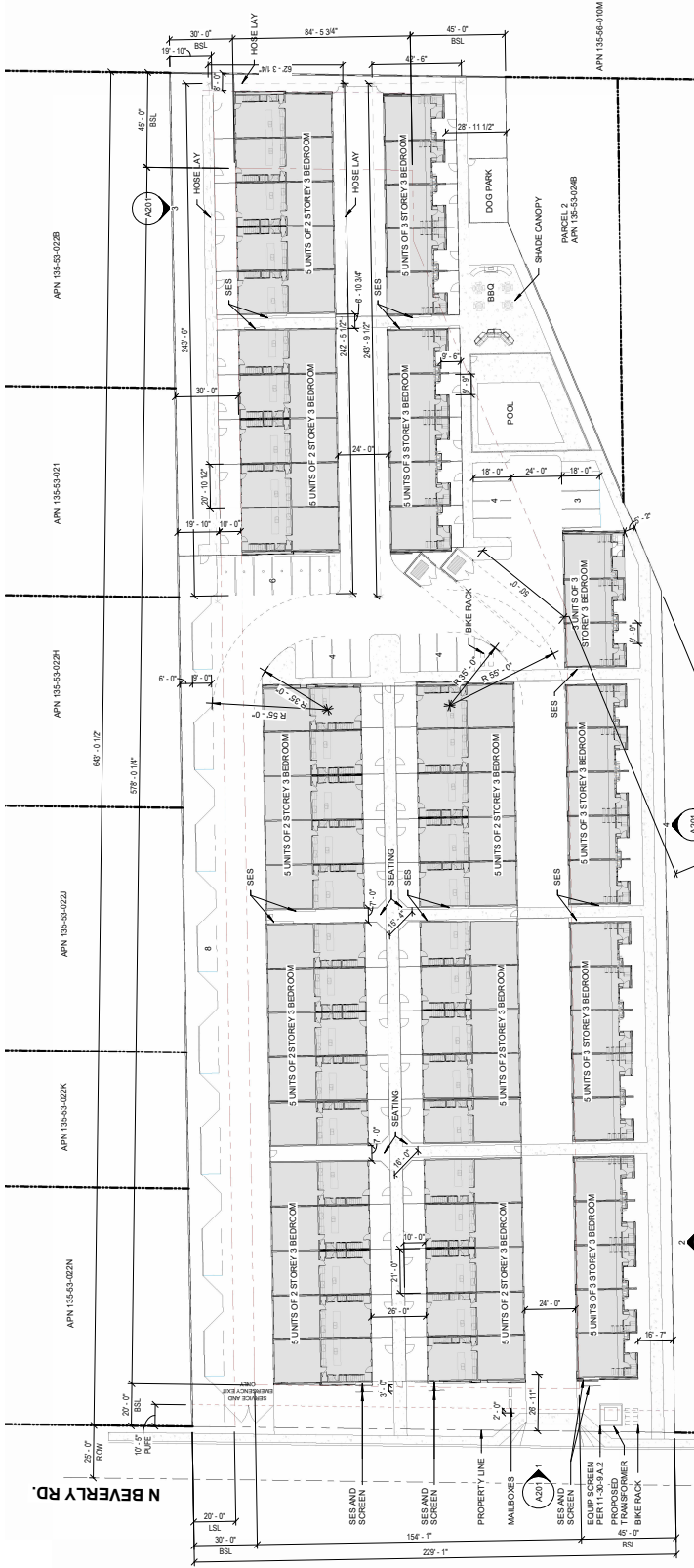
