SUNFLOWER CREMATION AND BURIAL

Mr. Bridges: Per the city of Mesa requirements, we are submitting this **Citizens Participation Report** for the above reference project.

Per Planning Division requirements we sent out several mailings to property owners and homeowners associations within both 500 and 1000 feet of the subject property, per mailing lists provided by Mesa staff.

Our initial letter dated April 27, 2023 and mailed on May 1, 2023, was sent to property owners and homeowners associations on the 1000 foot list. This letter notified the recipient of our client's **intent to construct** the 2800 s.f. crematory building adjacent to their existing funeral home. Included with the letter were copies of the project site plan and colored building elevations. Of the 300+ letters sent, 28 were returned to our office marked "Not deliverable as addressed unable to forward".

On May 18, 2023, we sent our three letters, a). The first letter was to owners and homeowners' associations on the 1000 foot list. This letter was **to inform of our application for Administrative Site Plan review**, stating that the Planning director would take administrative action on our request for the crematory as an accessory use on the site. In this letter we included a copy of the landscape plan, noting that we had send the floor plan and colored elevations in our initial letter. Of all the letters sent out, 3 were returned marked "Undeliverable...." b). The next letter dated May 17, 2023 was addressed to property owners and homeowners associations within 500 feet, was sent to our client who delivered them to City of Mesa Staff on Monday May 22, 2023, to be mailed by city staff. This letter was to notify recipients of our request for a **Special Use Permit** to allow the

crematory to be constructed. We included a copy of the landscape plan with these letters, and none were returned to our office. None of these letters were returned to our office c). The next letter dated May 17, 2023 was addressed to property owners and homeowners associations with 500 feet of the property. This letter informed recipients of the **request for Design Review approval** by city of Mesa Planning staff. None of these were returned to our office.

On Wednesday May 24, 2023 we received a call from you informing us of staffs **decision to hold a public hearing for the Site Plan review and Special Use permit** instead of approving at the staff level. We then prepared letters from the 1000 foot list and homeowners associations to inform them of this meeting. Having previously sent copies of the Site Plan, colored elevations and Landscape Plan, we again included a copy of the project Site Plan. These letters were sent to our client who delivered them to your office for mailing to the recipients. To date, none of these have been returned to our office.

Contained in the body of each letter, we identified ourselves and included our phone number and email address, should anyone have any questions or comments on the project. To date we received only one email from Velda Rose United Methodist Church, and that was to inform us that apparently their address is on the mailing list 9 times.

On Monday May 29, 2023 we sent our materials board with physical samples of the 4 colors and types of concrete masonry units proposed for the construction of the building along with paint color samples of the two colors for the overhead and man doors and the metal cap flashing. Those are to arrive today (6/1/23) and the owner will deliver them on Monday June 5, 2023.

We are anxious to continue working with your staff and hearing any comments of concerns from them along with any that the public may have.

The city of Mesa will be conducting public meetings for Planning and Zoning approval later this summer and I will notify you of each meeting in case you wish to attend.

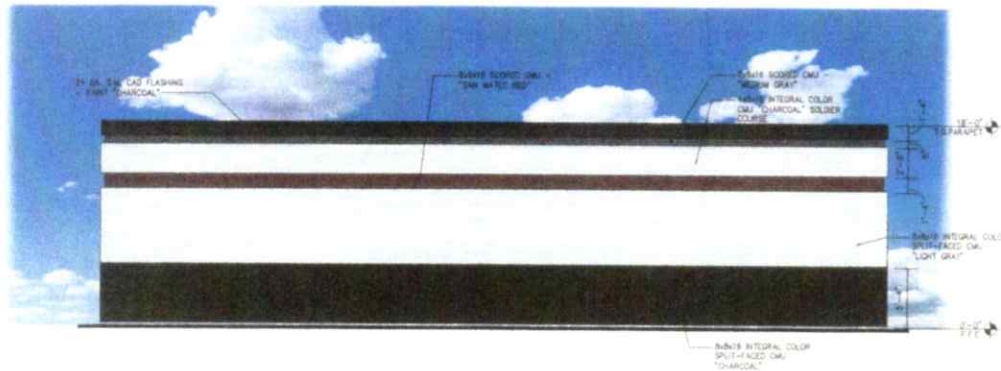

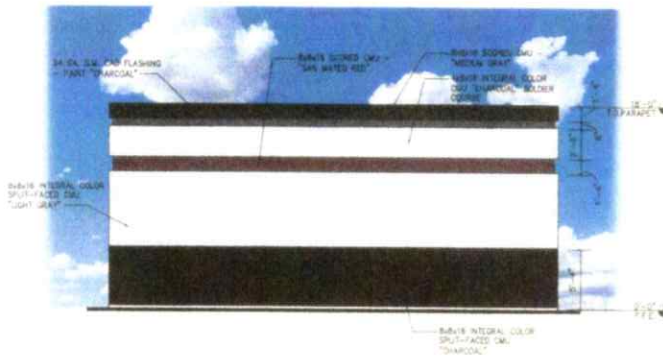
