Subject: Resolution of support for the submittal of a grant application by Boys & Girls Clubs of the Valley to the Fort McDowell Yavapai Nation in the amount of \$40,000 to support out-of-school-time programming for Mesa youth and approving the City Manager to accept and administer subsequent awarded funds as a pass-thru grant.

Purpose and Recommendation

This request is seeking a City Council resolution of support for Boys & Girls Clubs of the Valley's application to Fort McDowell Yavapai Nation for Proposition 202 funding. If awarded, the grant will provide \$40,000 in funding to support out-of-school-time programming. A Council Resolution supports this effort to secure a grant and commits the city to receive it on behalf of the non-profit and pass it through in its entirety to them if awarded. As these programs serve the needs of City of Mesa residents, staff recommendation is for Council to adopt this resolution.

Background

Boys & Girls Clubs of the Valley (BGCAZ) is a local non-profit organization whose mission is to empower young people, especially those who need them most, to reach their full potential as productive, caring, responsible members of the community and is the largest childcare provider in the Valley.

Boys and Girls Clubs for Mesa Youth provide out-of-school-time programming for Mesa youth, focusing on four Priority Outcome areas: Academic Success, Healthy Lifestyles, Good Character & Leadership, and Career Pathways & Workforce Development. Emphasis is placed on Academic Success, including Power Hour, the first hour of each day, wherein youth complete homework and can obtain help with assignments. Additional available activities focus on STEM learning, vital to interesting youth in and preparing them for 21st Century jobs.

BGCAZ addresses not only the academic needs of youth, but also their social/emotional development, physical and mental health, and provides opportunities for career exploration and workforce skills. Youth participate in fine art activities such as

photography and performance. The Clubs also provide nutritious snacks and full meals, using the opportunity to teach nutrition.

Boys and Girls Club of the Valley anticipates that 89% of the 784 youth served by this program request will be Mesa residents.

Discussion

A resolution of support for this grant request will complete the necessary documentation for the organization to file their application by the funder's deadline and be considered for funding from Fort McDowell Yavapai Nation. Mesa's participation in Proposition 202 Indian Gaming Grants has returned over \$1 billion to Arizona communities since its passage in 2002 from four surrounding tribal governments.

Alternatives

The only alternative to adopting this resolution would be to not adopt. Such an action would deny Mesa sponsorship for this request and require the organization to seek an alternate local government for access to this funding source.

Fiscal Impact

The fiscal impact on the City of Mesa, should this grant be awarded, will be negligible except overhead expenses in accounting to accept and reissue the grant check. The City does not administer the grant and signs an MOU or IGA with each tribe to limit our liability to only the pass-through transaction.
