In response to a question from Chairperson Cattani regarding the low survey responses and how to increase the response rate, Presiding Magistrate Tatz described the efforts that Court Administration has taken, including displaying QR codes in the courtroom. He mentioned the third-party survey company sends the surveys out.

Chairperson Cattani suggested emailing participants to increase responses and inquiring with other jurisdictions on their process.

Discussion ensued regarding how other jurisdictions handle the judicial surveys.

Presiding Magistrate Tatz stated he would explore additional options. He added that he is preparing his State of the Court to present at the next meeting in January.
