Subject: Use of a Cooperative Contract for the Purchase of One (1) Air Sweeper

(Replacement) for the Fleet Services Department and Falcon Field Airport

(Citywide)

Recommendation

Council is requested to approve the award as recommended.

Fleet Services Department, Falcon Field Airport, and Procurement Services recommend authorizing the purchase using the State of Arizona cooperative contract with Freightliner of AZ, LLC at \$379,000, based on estimated requirements.

Background / Discussion

Falcon Field needs a sweeper replacement. The current sweeper's hopper is rusted, sandblasted and all seals are failing, allowing dust exfiltration. As a result, the sweeper truck reduces air quality during operation. This poses a risk to the operator as they are exposed to breathing fine particulate dust that is kicked out of the hopper due to age, condition, and wear. The current sweeper has been welded and sealant patches have been applied to maintain operations. The hopper is no longer in a condition where repairs are effective, and a new sweeper is needed.

The State of Arizona's cooperative contract was recently competitively bid and meets the City's procurement requirements. Utilizing the State of Arizona's contract allows the City to receive competitive rates based on a formally solicited agreement. The City believes the price is fair and reasonable and soliciting for this product would not result in the City receiving more favorable pricing or terms.
