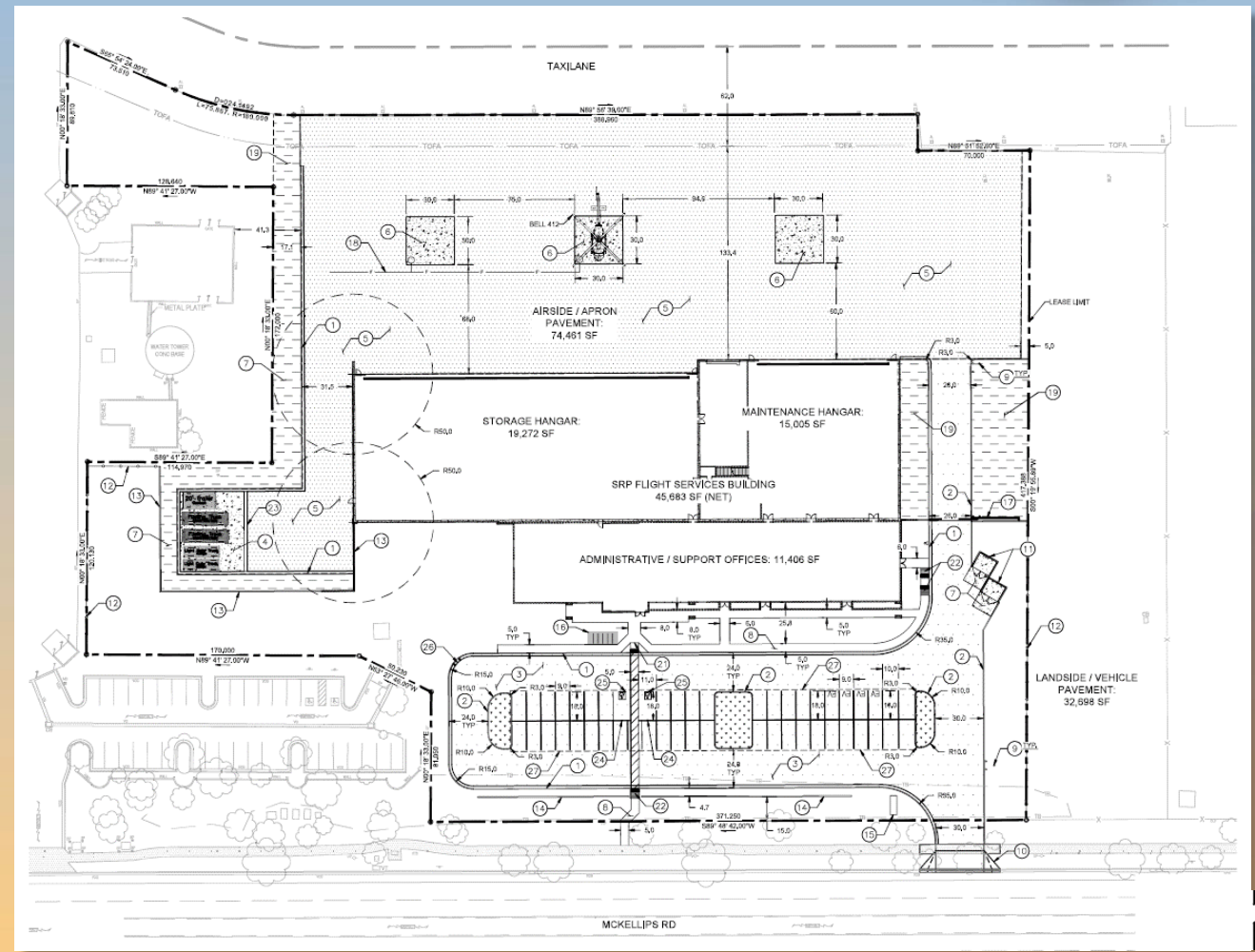

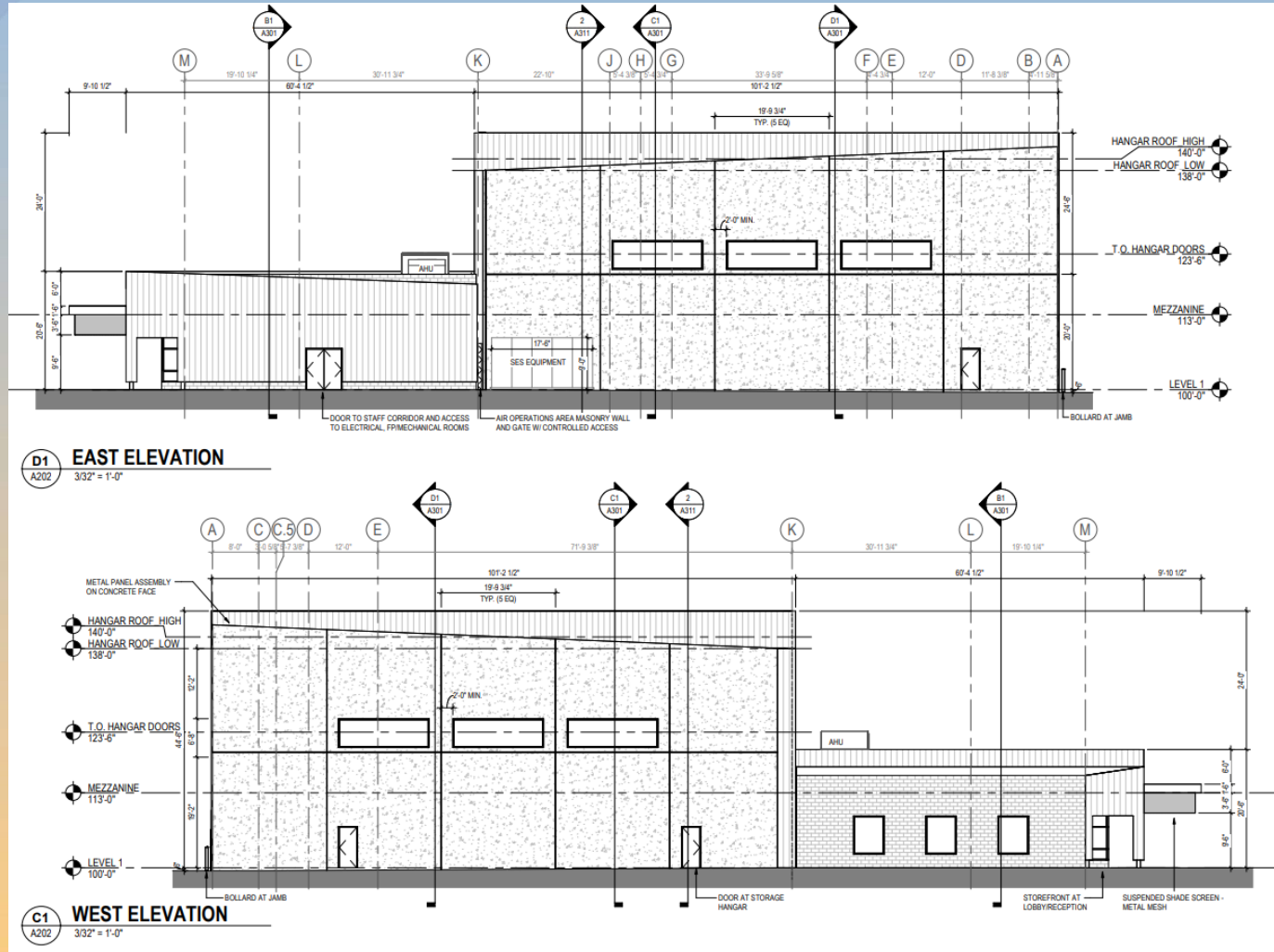
D1 NORTH ELEVATION

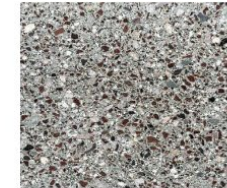

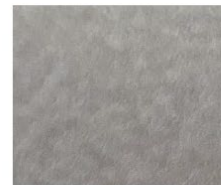
