The City Council of the City of Mesa met in the Council Chambers at City Hall, 20 East Main Street, on March 3, 2025, at 5:45 p.m.

Mayor's Welcome.

Mayor Freeman conducted a roll call.

Invocation by Pastor Ann Lyter with Velda Rose United Methodist Church.

Pledge of Allegiance was led by Cooper Shepherd from the Mayor's Youth Committee.

There were no awards, recognitions, or announcements.

#### 1. Appointment of Scott Butler as the City Manager effective June 1, 2025. (5 votes required).

Mayor Freeman expressed the opinion that Mr. Butler's experience, depth of knowledge regarding the City's operations, and his strong relationships with employees will ensure a seamless transition and have prepared him well to become the City Manager. He added that his work ethic, problem solving skills and leadership will help maintain a high standard within Mesa's community, while promoting the City's strengths within, and believes that his vision will lead Mesa into the future.

Councilmember Spilsbury expressed her support for Mr. Butler and noted that the City is on an incredible trajectory. She acknowledged gratitude to current City Manager Christopher Brady for his 19 years of service and thanked him for leaving the City in the best financial position it has ever been in.

Councilmember Somers thanked Mr. Brady for his longstanding service to the City of Mesa (COM). He congratulated Mr. Butler on his accomplishments with the COM in building a better Mesa and looks forward to collaborating with him.

It was moved by Councilmember Heredia, seconded by Vice Mayor Somers, that Scott Butler be appointed as the City Manager effective June 1, 2025.
