Recommendation

Council is requested to approve the award as recommended.

The Energy Resources and Transportation Departments and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder to Ferguson Enterprises, LLC dba Ferguson Waterworks at \$166,000 annually, with an annual increase allowance of up to 5% or the adjusted Producer Price Index.

Background / Discussion

This contract will provide valve and pull boxes with lids for the Energy Resources – Gas Utility and Electric Utility, and Transportation Departments. Materials and Supply places orders and maintains stock inventory as needed.

On November 7, 2021, Council awarded the contract to the single, responsive, and responsible bidder for Groups A and B. The City received No Bid responses for Groups C, D and E.

The City re-solicited and bid notices were sent for Group C – Gas Utility Valve Boxes and Lids; Group D – Traffic Signal Pull Boxes and Lids; and Group E – Electric Utility Pull Boxes and Lids to approximately 50 vendors on 9/22/2022. The City received two bid responses for Groups C, D and E. Award is being recommended to the lowest, responsive, and responsible bidder.
