Subject: Citywide Administrative Updates to Schedule of Fees and Charges

Purpose and Recommendation

The Office of Management & Budget recommends an administrative update to move the Federal & State Environmental Compliance Fee from the Solid Waste Fee & Charges schedule to the new Environmental and Sustainability Fee Schedule. If the proposed change is approved by City Council, the fees and charges will be effective July 1, 2025.

Background

The Office of Management & Budget gathers information from all departments on desired updates to Fees & Charges Schedules on an annual basis. Departments recommend these updates in their own report. The Federal & State Environmental Compliance Fee is currently the only fee listed on the Solid Waste Fee Schedule. With this change to move the Federal & State Environmental Compliance Fee, the Solid Waste Fee Schedule will be eliminated, and an Environmental and Sustainability Fee Schedule will be created containing this one fee.

Discussion

Environmental and Sustainability had been a division within the Solid Waste Department. During FY 2022/23, the division became its own department. Because the Federal & State Environmental Compliance Fee is managed by the Environmental and Sustainability Department, the Fee Schedules should be updated accordingly to reflect the correct department. There is no fiscal impact resulting from this change.

Alternatives

Taking no action will result in no fiscal impact, as the departments have been operating in this capacity.

Fiscal Impact

There is no fiscal impact to make these administrative updates and corrections to the applicable schedules.
