Subject:	Two-Year Term Contract with Two-Year Renewal Options for Non-Functional Turf Removal Conversion Project for the Parks, Recreation, and Community Facilities Department (Funded by Water Infrastructure Finance Authority (WIFA) Grant and Environmental Compliance Fee) (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Parks, Recreation, and Community Facilities and Environmental and Sustainability Departments, and Procurement Services evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposal from Mariposa Landscape Arizona, Inc. at \$1,985,000.00 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

This project is a grant funded Water Conservation project. The services involved are the removal of 221,683 square feet of selected turf that lies within fifty-four (54) different parks and retention basins within the eligible grant funding areas and that has been deemed as non-functional; installation of a concrete curbing border and granite in these areas; and modifications to the existing sprinkler systems for the remaining turf area.

This project will save approximately 5.7 million gallons of CAP water annually. This project will also improve the aesthetics of the parks and basins, as these non-functional turf areas are difficult to grow grass in. This project has a secondary benefit of reducing the amount of conflicts and legal liability issues that arise from having turf directly adjacent to residential block walls.

Staff issued a Request for Proposal (RFP) to all registered and known landscaping contractors. Three (3) proposals were received. Outdoor Systems Management, LLC did not meet the minimum requirements and did not move forward in the evaluation process. The remaining two (2) proposals were evaluated by a committee based on the evaluation criteria as stated in the solicitation. The proposal from Mariposa Landscape Arizona, Inc. scored 253.86 out of 300 points and is being recommended for award. The evaluation committee unanimously agreed on the recommendation.
