### 1. Take action on the following resolution:

- 1-a. Approving and authorizing the City Manager to enter into an Intergovernmental Agreement with Maricopa County, Human Services Department to accept \$6,250,000 in Coronavirus Aid, Relief, and Economic Security Act (CARES Act) funding to be spent on providing rental assistance to eligible Mesa residents impacted by COVID-19. **(Citywide)**

Mayor Giles expressed appreciation for the Maricopa County Board of Supervisors for supporting the City regarding the prevention of evictions in the City of Mesa.

Vice Mayor Freeman voiced his appreciation to the Maricopa County Board of Supervisors for the CARES Act money to help with the relief of rent and utilities in the community during the pandemic.

A resolution approving the Intergovernmental Agreement with Maricopa County, Human Services Department to accept \$6,250,000 in Coronavirus Aid, Relief, and Economic Security Act to provide rental assistance to eligible Mesa residents impacted by COVID-19. – Resolution No. 11565

It was moved by Councilmember Thompson, seconded by Vice Mayor Freeman, that Resolution No. 11565 be adopted.
