Specifically, the applicant has not obtained the Tenant Improvement Permit or the Certificate of Occupancy for the building expansion into Suite 2N as required by Mesa City Code 4-1-4. Additionally, the applicant has not obtained an alarm permit from the Mesa Police Department Alarm Unit as as required by Mesa City Code 6-15-6. A yes vote for this item on the consent agenda will constitute City Council's order recommending disapproval of the liquor license application. (Ariz. Rev. Stat. Ann. § 4-201 and Ariz. Admin. Code § R19-1-702).
