4. Hear and discuss a presentation on Mesa's draft Citywide Workforce Development Strategic Plan, including efforts for internships, apprenticeships and other student career pathways into the City.

Ms. Sarah Tolar, the Education and Workforce Administrator, presented to the Board an overview of the City's drafted Citywide Workforce Development Strategic Plan. She shared the City's mission to align education, business, and workforce development to create a strong, inclusive and future-ready pipeline. She expanded on the four Strategic Priorities within the plan: support workforce alignment and



growth, build intentional connections, enhance internal workforce development opportunities, and improve post-secondary attainment.

Ms. Tolar explained that Mesa is continuously assessing workforce needs to ensure job seekers and employers are equipped with the right tools and information. In its role as a convener, the City serves as the liaison and connector for Mesa job seekers, employers and educators for available resources and support. The City will remove barriers and leverage partnerships, align with local, state and national efforts and amplify career path opportunities to create a more equitable and accessible education-to-career pipeline for all community members.

Additionally, Ms. Tolar highlighted opportunities (such as job shadowing, service learning, internships, and apprenticeships) where the City is actively engaging the future workforce. She concluded her presentation by addressing questions and responding to feedback from the Board.
